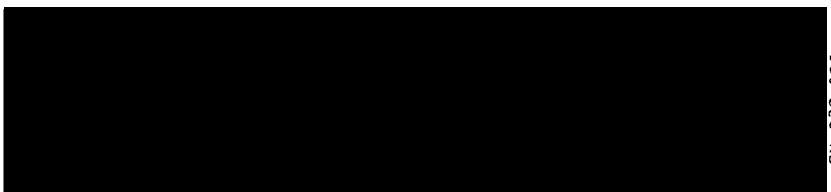

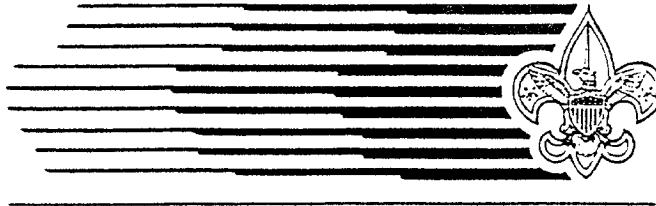

Dear Mr. LaBadie:

After careful review, we have decided that your registration with the Boy Scouts of America should be suspended. We are therefore compelled to request that you sever any relations that you may have with the Boy Scouts of America. A refund of your registration fee is enclosed.

You should understand BSA membership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to suspend registration whenever there is a concern that an individual may not meet the high standards of membership which the BSA seeks to provide for American youth.

If you wish to have this decision reviewed by a council review committee, please write to me, explaining your version of the facts supporting your claim that your registration as a BSA member should be reinstated.

Mr. Booker,

It is so hard for me to think back and discuss what happened. I feel so sick and gross inside when I think about it. This is something I've bottled up inside me for so long because it embarrasses me as much as it feels humiliating. Well, I'll do my best to tell this side of the story through my eyes as I saw it.

I've known Al LaBadie for about 10 years thru scouting. I've worked on numerous scouting activities with him, anything from campfires to summer camps and troop activities.

Al was very generous with his time for scouting and amongst his numerous activities one was counseling merit badges. Al counseled a couple different merit badges but the one most of the boys were involved in was Lifesaving. We all went to Al because he was easy going and he had a pool at his apartment in Huntington Beach which we used.

Sometimes when we were finished working on the merit badge all of us would go back up to his apartment. When you're at the age of 12, 13, 14 and you're with your buddies

a lot of the talk is about sex, or who is the toughest, ect. when Al put a dirty movie in the VCR. we really didn't know what to say, but we watched it because we were curious as to what men and women did while having sex. It seemed that a lot of the discussion between Al and us boys was about sex. One time I remember him asking us certain questions about our mom's and dad's and what we thought about them doing different sexual acts to each other.

About 3 or 4 years ago Al was called on the carpet for showing us these movies and I was too scared to mention anything else that happened so I sort of buried it deep inside me and hoped it would never come up again.

Al was a very good friend of the family and he ~~was~~ would come over to the house a lot and ask my parent if I could do errands or go places with him. My parents said it was okay and I was glad to get out of the house. We did lots of things together, <sup>would</sup> go to the swapmeet, carnivals, amusement parks, all kinds of different things. I had a lot of fun because in a large family which I

from, we didn't do family things like that because it would cost a fortune. I guess I liked being spoiled because I've never felt it before.

I found it easy to talk to Al, he always listened and seemed like he understood my problems in life (family problems). Sometimes we would sit in his jacuzzi for a while then we would decide it was getting late and I should get home. When we would go back to his room it seemed like a movie would be placed in the VCR and going home seemed so far away.

A game, kind of foreplay I guess, would start. The jacuzzi, the movie, then he would give me a back rub or he would ask me to give him one. Sometimes if I was dressed he would start to undress me. I layed in his bed watching this movie with him <sup>121</sup> rubbing my back, then my legs, then he would turn me over on my back and start rubbing my chest then slowly start caressing my genitals. On two occasions he started kissing then sucking on my penis, I didn't know what to do. I layed there flat on my back unable to move. I wanted to get up but I felt like I was trapped. I was scared that something would happen ~~to~~ to




me. I thought of my parents but how could I tell them. This is when I decided to forget what happened and put it out of my mind.

After that I kind of separated myself from Al. I wouldn't let him hug me or let myself do things alone with him anymore. He would ask me to do things with him but I always made sure I wasn't alone. There was always a friend with me. I knew this would be safe because he never tried to do anything when a big group was around. I guess he got a hint because he stopped asking me to do things and then he stopped coming over to the house.

From then on Al and I only saw each other at meetings or just spoke on the phone about scout things nothing else happened between us. I don't know why I didn't say anything earlier I guess I was just glad it stopped.

The information stated in this letter is the truth and I as an Eagle Scout swear to it on my sacred honor.
