## Police talk armed man out of suicide

Gainesville police rerouted pedestrians and vehicles around the 1600 block of NE 23rd Avenue Thursday morning while they spent four hours talking an armed man out of harming himself.

Police said the man, armed with a 30-30 rifle, was apparently suicidal, but did not threaten anyone else. He never fired a shot and eventually handed the gun to officers outside his front door.

The standoff began when Bruce Braut, 24, called police at about 5:15 a.m. to say he was suicidal and armed with a rifle. Police, including SWAT team members, soon surrounded his house at 2209 NE 16th Terrace.

Officers and crisis counselors talked to Braut by phone for hours before persuading him to come out.

"He was agitated off and on," said Lt. Sadie Darnell. "It was an inconvenience to a lot of people, but the bottom line was we wanted him to come out of there without anybody getting hurt."

Police said they won't talk about the man's problems except to say that he was apparently having difficulties over a girlfriend.

Darnell said Braut wasn't arrest-

ed or charged because there was no hostage, no shots were fired and no one but himself was threatened.

But Darnell expressed surprise Thursday evening when she was told that a neighbor reported that Braut was back at his home later in the day. Darnell said that when she called the Crisis Stabilization Unit — where police records show Braut was taken — she was told they had no record of his arrival there.

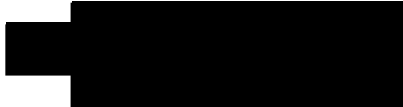
Darnell said she was unable to find any local agency that knew of the man's whereabouts, and called CSU back.

Braut is the son of Joel and Diane Braut, who died in a murder-suicide behind Gainesville City Hall in October 1986.

Joel Braut was waiting in a car near city hall while his estranged wife parked nearby upon returning to her job. They argued, struggling over a handgun. Finally, he pushed her to the ground and shot her several times with a .357 Magnum. He reloaded the gun, fired again at her, and then shot himself.

Dear Mr. Beauregard:

After careful review, we have decided that your registration with the Boy Scouts of America should be denied. We are therefore compelled to request that you sever any relations that you may have with the Boy Scouts of America.

You should understand that BSA membership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to refuse registration whenever there is a concern that an individual may not meet the high standards of membership which the BSA seeks to provide for American youth.

If you wish to have this decision reviewed by a BSA regional review committee, please write to the regional director within 60 days of the date of this letter, explaining your version of the facts supporting your claim that your possible registration as a BSA member should be reinstated. The procedures for a review of this decision are attached.

November 22, 1989 10:30 a.m.

I visited with Father Roland Julien, Pastor of St. Patricks Roman Cahtolic Church in Gainesville, Sponsor of Scout Troop 82.

I shared with Father Julien that we had received some concerns of Al Beauregard regarding his activities with youth. I asked Father Julien if he had any expressions or concern of Al Beauregard from anyone in the past years. He said he had not.

I asked Father Julien if he could recommend people that I might talk with that had been active with the Troop. He suggested that I check into the background of Mr. Beauregard's activity before he moved to Gainesville (approximately ten years ago) there seems to have been some concern expressed but that was before Father Julien was in this parish and he was not aware of any detail. He suggested I get in touch with [REDACTED] and [REDACTED] who became Eagle Scouts with Mr. Beauregard also [REDACTED] who has a son in the Troop, perhaps [REDACTED]  
[REDACTED]

November 22, 1989 11:00 a.m.

I visited with Captain Robert Mitchell, Gainesville Police Department, Captain Mitchell advises that [REDACTED] had previously informed Pastor Julien that there had been some questions about Al Beauregard. He suggested I talk with [REDACTED] [REDACTED] regarding the previous information he had of the concerns.

Captain Mitchell indicated that an officer by the name of Sonny Chamberlain who (was working at the Police Department reception desk on November 22) had expressed concerns to him regarding Beauregard. This information was shared in a confidential manner.

Captain Mitchell suggested that I also might contact Assistant Scoutmaster [REDACTED] who is currently a University of Florida student, address [REDACTED] [REDACTED] home phone [REDACTED]. He also suggested contact with [REDACTED] Senior, and Junior, they had been active in the Troop and for some reason were unhappy with their troop experience.

Riffen (H) [REDACTED]

November 30, 1989

On this evening [REDACTED] and [REDACTED] met with Eagle Scouts [REDACTED] and [REDACTED] both of Troop 82. After other elements of conversation these two Scouts were asked whether or not they had been on any camping trips with Albert Beauregard and had witnessed possession of Playboy magazines, etc? Comments were made that the actual magazine was brought by a boy and [REDACTED] had a comment that "he had lots of dirty stuff" (Referencing to Albert Beauregard).

January 25, 1990  
6:00 PM

I visited with [REDACTED] (DOB [REDACTED]) at his home at [REDACTED]. [REDACTED] informed me that he had been molested by Al Beauregard from shortly after he became a member of Troop 82 at 11 years of age until he left the troop at age 18.

[REDACTED] had been molested in the restroom of the church, in Beauregard's van, and at Beauregard's house. Also on camping trips at various places in Florida and the Carolinas.

[REDACTED] had been forced to masturbate Beauregard, and perform oral sex on Beauregard. On one occasion of his refusal, Beauregard pushed [REDACTED] and he fell and blacked an eye.

[REDACTED] has been so traumatized that he would not play ball with school teams because of the need to change clothes in other males' presence. He played ball with the city leagues because he could put a uniform on at home before he went to the practice or game.

When I visited with him, [REDACTED] sat in chair between myself and within six feet of the open front door. This seating arrangement was a deliberate action by [REDACTED].

I ask [REDACTED] if there were other youth in the troop that I should visit. He mentioned [REDACTED].



January 27, 1990 - 7:00 p.m.

I called for [REDACTED] at [REDACTED] of [REDACTED]

I talked with Mrs. [REDACTED] and asked if [REDACTED] was at home, she informed me he was not. I told her I was with the Boy Scouts of America and was interested in talking with [REDACTED] regarding some of the history of Troop 82, she informed me I would need to get in touch with Mr. Al Beauregard, I told her I intended to do so. I asked when [REDACTED] would return and she informed that he was currently in the Marine Corps and would not provide me with his address or phone number so that I could get in touch with him.

January 31, 1990 - 2:00 p.m.

I visited with [REDACTED] in apartment [REDACTED] (on route [REDACTED] across from a [REDACTED] in the town of [REDACTED]) her son [REDACTED] came home about the time the conversation was underway and I had a discussion with both of them present.

[REDACTED] indicated he had no suspicions of questionable activity about Al Beauregard and [REDACTED] expressed the same sentiments. I did get the information that [REDACTED]'s father ([REDACTED]) had put his foot down with Al Beauregard for showing an unusual amount of attention to [REDACTED]. I secured the telephone number of [REDACTED] and information that he was a district manager with an insurance company in [REDACTED]. [REDACTED] was in the Air Force in [REDACTED]. I also found that [REDACTED] worked at [REDACTED]

January 31, 1990 - 3:30 p.m.

I visited with [REDACTED]

I shared with [REDACTED] the youth protection emphasis with the Boy Scouts of America and asked him if he had any reason to be concerned about the leadership exhibited by Al Reauregard. He responded that he did not have particular concerns. He did acknowledge that pornographic material was often available on Troop outings. He acknowledged that Al Beauregard paid a lot of special attention to [REDACTED]

January 31, 1990 - 4:00 p.m.

I visited with [REDACTED], Manager of [REDACTED], in [REDACTED] [REDACTED] indicated that he had no suspicions about Al Beauregard and his relationship with young men. He did acknowledge that he and [REDACTED] were very close and he did infer very casually that he wouldn't be surprised to learn that Beauregard was homosexual. I asked [REDACTED] if he thought [REDACTED] was homosexual. [REDACTED] response was that there was no way that his brother [REDACTED] would be homosexual and him not be aware of it. I left my business card and telephone number with [REDACTED] and asked him to call if he felt there was any thing surface that I should be aware of.

January 31, 1990 - 5:00 p.m.

About 5:00 p.m., Joe Lowery, Chairman Alachua District, and I went to Blount Mauerson Pontiac Garage at [REDACTED] and found Al Beauregard (shop foreman) in his office in the repair area. We ask Al if we could speak with him in private and he granted us the opportunity to do so.

I asked Al if he was familiar with the Youth Protection Program and he indicated he was slightly familiar with it. I advised him that there had

been concerns expressed of his leadership style with youth and that following interviews with several people it was indicated that the Boy Scouts of America felt it was desirable that he not have any future contact with youth in the B.S.A. and that he not continue to be registered member. I read the letter and handed it to him as well as informed him about his rights of appeal and gave him a copy of the appeal process.

Beauregard's response was completely matter-of-fact and made a low vocal statement to indicate "well if that's the way you want it, okay." [REDACTED] and I shook hands with Beauregard and left the premises. We were both surprised with his rather casual reaction to the whole process.

February 1, 1990 - 9:30 a.m.

Mary Day Coker, State Attorney's Office in Gainesville called [REDACTED] Captain Robert Mitchell, Gainesville Police Department was in her office raising the question with her regarding the victim's concern of public awareness of his identify in the prosecution process.

Ms. Coker indicated that his name would not be allowed in the media or any publication, by state statute. She also indicated that his identity would part of the court process and record.

She stated that Detective McCall heads the child sexual abuse division of the Sheriff's Department. If it was indicated that the criminal actions occurred in Alachua County, Julie McCall would be the one handling the investigation.

February 1, 1990 - 9:45 a.m. (approximately)

I returned a phone call to [REDACTED] and shared the statements that Ms. Coker had shared with me regarding his ability to stay anonymous. [REDACTED] expressed great concern about his ability to share his abuse experience with his future wife and appeared to feel very good that Ms. Coker or Julie McCall would accomplish this task. I asked [REDACTED] if it would be alright to have Ms. Coker call him and he agreed to talk with her. [REDACTED] indicated he was currently working at [REDACTED] and would be out of the house from about 2:30 to midnight today.

I asked [REDACTED] to be certain that he made contact with Carol Albert of the Springer group regarding signing a release to make it possible for me to secure a statement from them about his former counseling costs. [REDACTED] indicated that he would do that today.

February 1, 1990 - 11:15 a.m.

[REDACTED] called. (He is the father of [REDACTED]). [REDACTED] is a district manager of [REDACTED] in [REDACTED] his business phone is [REDACTED], home phone [REDACTED].

His son [REDACTED] had called him yesterday evening (January 31, 1990) informing him of my visit with [REDACTED] late that afternoon. His father was initially somewhat hostile and concerned that his son's "Godfather" had been suspected of child abuse. After discussion, Mr. [REDACTED] eased his hostility and became aware that it was certainly possible for someone close to family members to be an abuser. I indicated that if his son [REDACTED] (with whom we had not talked) had been abused and there was a problem that surfaced with him that the Boy Scouts of America would infact make counseling available if it were felt to be necessary. Mr. [REDACTED] expressed appreciation for this.

Mr. [REDACTED] had asked whether or not we had discussed this issue with Al Beauregard. I informed him that Beauregard was visited at about 5:00 p.m. on January 31,, by Steve Moore and Joe Lowery. The letter or removal and appeal process was delivered with him at that time.

Mr. [REDACTED] indicated that the hostile conversation that had been referenced that occurred between he and Al Beauregard regarding Beauregard's attention to [REDACTED] was focused around Beauregard's "replacement of loyalties to [REDACTED]" of his father, Mr. [REDACTED]

He indicated that no sexual or abuse issues were either suspected or discussed. Mr. [REDACTED] indicated that Beauregard apparently was not too successful with his own children and moved to become very close with [REDACTED].

Mr. [REDACTED] did indicate that [REDACTED], with Mr. [REDACTED] blessing, lived with Al Beauregard for 3 or 4 months during the time Mr. [REDACTED] moved to Savannah.

The conversation ended quite well with the exchange of phone numbers and the invitation to call if there were any problems or questions.

February 1, 1990 - 1:35 p.m.

[REDACTED] called from Nebraska to ask what the concern were that were about Al Beauregard.

I shared with [REDACTED] the Youth Protection Program of the Boy Scouts of America and why it existed and how it worked. In the course of the conversation I asked [REDACTED] if he had any reason to question if Al Beauregard would be an appropriate leader for young people? He was quick to indicate that he had no concerns about Beauregard and his relationship with youngsters.

I asked if I could have his phone number and address in case I had to get back in touch with him and his address is as follows: [REDACTED]

[REDACTED]. His home phone number is [REDACTED], and he is usually home after 4:00 p.m.

[REDACTED] had indicated that [REDACTED] had called him the previous evening and advised him of my conversation with [REDACTED]
