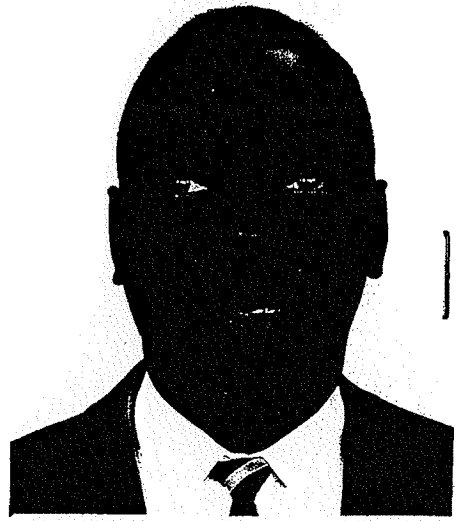

This is what I was doing when they arrived. I invited them all in, showed them the house, and took them into the basement to my Dad's bar where we all had a drink. They were all average drinks and probably on the west side compared to what I knew they were accustomed to. Al, Bill, & Corby had one shot of bourbon straight and on the rocks, and I mixed mine with "talk-up." After we finished we went upstairs where we found my mother & grandmother who just came back from the cemetery. My Dad who had been taking a nap also awoke and joined us. We chatted for a few minutes and then left.

In the car we chatted about the city of Chicago and just passed the time away with small talk. As we got close to Valleyview, ~~we~~ Al asked Corby and the kids to come on over to the ~~Steff~~ cottage for a drink before supper. She tried to excuse herself since it was after six in the evening and the kids hadn't eaten yet. She also said something to the effect

that meat loaf was out of the question now and it would have to be hamburgers. Since I was still under the impression that this was going to be a barbeque as said that was o.k. with me I like hamburgers. She didn't say anything but gave me a very funny look.

Well Corby and the kids both come in along with Bill, Al, and myself. Where Al ~~was~~ poured them all bourbon on ice and mixed a little water with theirs and he also mixed ~~I~~ me a stronger than average highball. Al's drink was more like a double or triple. We chatted briefly while the kids watched "Lassie" and during this time Jerry Botts and his wife ^(LaVon) joined us. Al poured a good sized drink to Jerry and tried to coax LaVon to drink. She wouldn't and after approximately 15-20 minutes ~~to~~ she left. A short time thereafter Bill, his wife, and children also left telling me they would not probably see me again until next week Saturday or Sunday and repeating this several times, which was strange since on the other

occasions I when I was ~~at~~ out there ~~on~~ ~~an~~ al. ways visited with them later in the evening. This also was to have been a barbeque and I didn't quite understand, since La Von ~~o~~ had also mentioned something about cooking supper and she had told Jerry he had until 7:15 PM to get back home. Jerry was still there and he had one more drink and left. It seemed like Al wanted him to stay but Jerry had once before stayed and La Von was quite upset about it. So when Jerry made mention of that incident Al agreed that he should go. During this hour or so ~~—~~ Al probably had three drinks but it may have only been two or it could have been four or more. I wasn't counting. I was still nursing my first.

After Jerry left I knew that this was just a dinner visit with Al and no barbeque was intended. We then began to make supper Al did most of the cooking and I did most of the talking. ~~o~~ We were interrupted once when Brewster and Sarah snuck on over to Al's house. Shortly thereafter ~~the~~ Bill came after them

and was displeased that they had run off without being excused. Al then poured each a drink including Bill and himself. I was not ready yet so I did not drink. After approximately another 10-15 minutes Bill and the kids left for good whereupon they did not return for the rest of the evening. We then finished preparing supper as we talked about raising children and the lack of force parents forget in this day and age. Al also made mention of his own children (3 boys, 2 of which are twins and his wife but only briefly but kindly. I was happy to hear him speak of his family since this was the first I had heard of his family, but although I tried to pursue this topic we were soon back to talking about ~~with~~ me and my experiences as a school teacher.

By this time the food was ready and in fact it was even cold because we just didn't eat. We were too busy talking. During

about the same subject where Al also told me he had been engaged twice ^{before his present wife} and that anything that ~~was~~ went on tonight was strictly between him and me. At that time I agreed since I also told him about some of my mixed feelings of Boy Scout work.

Several other things happened then ~~on~~ at least two occasions while we were standing he approached me put his arms around me and once kissed me on the shoulder and on another time patted me on the rear-end. I thought that he was a very warm and affectionate man and perhaps a little lonely and I left it go at that. On one other occasion he approached me from the side put his arm around me and gave me a hug.

We finished cleaning the supper off the table and although we didn't do the dishes it took some time for the whole meal. By this time it must have been 9:00 or 9:30 P.M. We watched T.V. for a ~~time~~ while and when nothin

was on that appealed to us he asked if I would like to play cards I said sure thinking of Cribbage Gin Rummy, or 2 handed Pinochle. He went and got the cards and his bath robe which he placed over the curtain rod on the door which he said had a draft coming from it. The shades were already down and maybe or maybe not the door was locked I really don't know.

Anyhow I pulled up a chair across from the coffee table facing him with my back to the T.V. and the rest of the house. He asked me to sit next to him on the couch where it was more comfortable, I did. He decided we should play Tonka which he described to me. After hearing it described I wasn't impressed it appeared to me to be just a game of chance that you could just as easily program a Robot to play as a human being. I kind of said half-heartedly that that would be alright. When he said, "Since I don't want to take your money ~~with~~ we'll just blow her clothes." I said "no thanks."

but I'm not interested in playing that way. He argued half-heartedly about it and then became somewhat nervous. He stood up and invited me to go with him to the Bedroom, Kitchen or Bathroom for five minutes he didn't say which he just nodded that way. I again said no and he again argued a little more gamely this time. Even asking me to go for only two minutes I again refused and then he really broke down kneeling on the floor in front of me he put his head in my lap and kind of whimpering said "Let me kiss it - just once," meaning my penis. With this he also began feeling my body I shoved his hands away little by little and he became a little more calm and finally got up excused himself for a minute and went to the washroom. At this time I was more afraid of the future than I was of the present so I stayed not knowing what would

happen if I let him know by any overt action that I ~~was~~ was going to report him. After a while maybe 5 ~~more~~ minutes he came out and we talked and then he took me home. I have tried to remember what happened ~~at~~ from the time he entered the washrooms on but I can't. I know my only thought was to keep him happy and not to let him think for one second that I was going to give him away, if I even was ~~which~~ at that time I really didn't know what to do.

My only reason for reporting this incident is that I can't with a clear conscience believe that a man, any man, suffering from this illness is in the long run of any benefit to boys and in particular Boy Scouting. I consider this closed between me and him and am ~~doubtful~~ that this is 1-1-11 11 11

and have prayed for him that this will be the end of this sickness for him.

This to the best of my ability is the truth as I know it.




Following the original interview, this date, in the Scout Executive's office with Messrs. Barber, Hill, Frans, and Anglim present, Messrs. Anglim and Frans interviewed Mr. [REDACTED] in Mr. Frans's office. The purpose of the interview was to again give Mr. [REDACTED] the opportunity to again describe in detail the card game that took place, admitted by both Mr. Hill and Mr. [REDACTED] in separate interviews.

Mr. [REDACTED] admitted his original statement was in error, and that in fact he did participate in the card game described, and that in fact Mr. Hill did engage with him in a homosexual act.

He indicated that his reason for the erroneous original information was due to his fear of further involvement, and the protection of his reputation, as he felt that was the first and only time he had ever been engaged in such an activity.

The foregoing is a true record of our interview with Mr. [REDACTED].
