Dear Al:

Following your July 7 phone call, we contacted Schiff Scout Reservation and they dug back in their records and pulled out Mr. Miller's application for employment for 1961 at Schiff. He apparently applied for Program Director and was employed either as that or as Provisional Scoutmaster. We do not know how many years he worked there but he had not been there since 1964. At any rate I have a good deal of his personal data such as birthdate, Scouting experience, employment experience, education, interests, etc.

Now we have the letter and newspaper clipping you have just forwarded. I have read them all and it is clear that the implications, innuendos and suggestions are not what you and I would believe are desirable from a moral point of view. There is, of course, no direct evidence that any immoral act has occurred but there sure is the implication that such has occurred or at least been suggested. At the very least, the tone of the letters and newsclipping is undesirable and I would have to question whether it is in the best interests of either individual. In addition, the fact that the original contact was made in 1964 and that the correspondence you forwarded is all late 1968 and early 1969, is another rather good indication, to me at least, that whatever has gone on in the past has been, or possibly still is continuing.

It is my judgement that we should place Mr. Miller in our Confidential File so that we can stop any possible future registration by him in the Boy Scouts of America. I do not believe that any further action should be taken at this time for there is not sufficient evidence for anyone, such as Mr. Selin, to prosecute Mr. Miller or to take any similar action against him.

Also included is a photostatic copy of a news item which pertains to one of letters, "read and destroy" as is the copy of the news clipping which was written and sent to [REDACTED] by a man known as "Doc".

Howard, I would appreciate it very much and I know the father would your reaction to this material and some advise as to further steps to be taken by the father or Scouting.

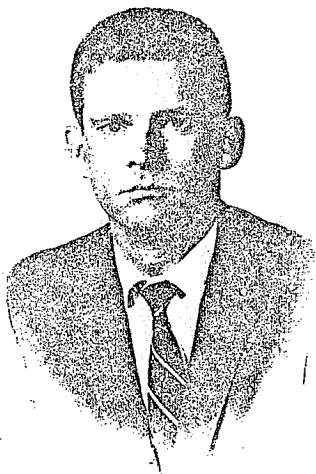

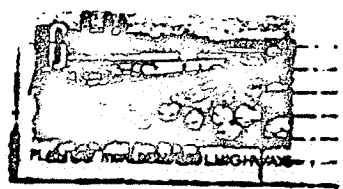

Just a couple of quickie notes.

1. Your letter to Operation Crossroads Africa was posted last Friday afternoon. Good luck! Let me know how you make out!
2. I am placing a couple of packages in the mail to you today at noon. There is nothing fancy in them, just a Christmas thought.
3. I am not mailing camera to you at this time. Although time is of the utmost importance, I am not quite sure that the Christmas rush is the best time to mail it. Perhaps if you get a chance to visit during semester break, we can use it then--also you can carry it back with you.
4. Last Saturday's session with our two youngsters was quite rewarding. Even with the loss of one of our better controls, we managed to get a reaction of tearful happiness from a youngster that I had some doubts about. He was one of the most bitterly cynical youngsters I have ever seen. I have been counseling S. for some time, but I must admit that [REDACTED] (one of our controls) was the one who made the breakthrough. Love is a strange and powerful weapon. I think, sometimes, the younger generation is more understanding of its potential than some of us who have been around longer. Perhaps the secret is in the expression of this love. To be sure, the Puritan stigma of dirty as attached to love is no help. Herein, I think, is one of the greatest hangups of young and old alike--love--the expression of same--and the implication that this is dirty. DO YOU REALIZE THAT THIS MAKES THE BEARING OF A CHILD (INCLUDES CONCEPTION) QUITE A SHAME RIDDEN AFFAIR? NO WONDER SO MANY MEN AND WOMEN TRANSFER THEIR "GUILT OF REPEATING THE ORIGINAL SIN" TO THEIR CHILDREN STRANGLING THEM LONG BEFORE THEY HAVE HAD TIME TO MATURE.

I really didn't mean to get on a soap box about this. It would be wise to consider it, but I don't think I would discuss this subject with anyone--yet! There is a lot more to it. I would be interested in your reaction, however. I would also be interested in any thoughts that you might have in the way of expansion of the idea. This might involve what you have read about the so called "free-love" or promiscuity of today's young people, and also your own feelings on the subject.

Hi [redacted],

By this time, I would suppose that you have had your fill of the bird. I do hope that your Thanksgiving break was an enjoyable one. I can't say very much about mine. My alma mater got the living be-feebers beat out of them 55-6. Oh well, maybe next year.

I have enclosed a newspaper clipping that I mentioned to you earlier. The two young men that I told you about were members of this "group" and deemed salvable. It would appear that we were more successful last weekend than we had even hoped to be. As for [redacted] and [redacted], they apparently are none-the-less- for wear. I had long talks with both of these young men. Both contend that any apprehensions are completely eradicated by a sense of accomplishment. I suppose this was one reason that I was so up-tight last Saturday. I knew the kind of pressure that they would be up against, but I didn't realize the extent.

Having mentioned MacLuans "The Medium is the Massage" to you during an earlier conversation--I can only mention that this is a basic concept in this study. [redacted] and [redacted] were (or rather their bodies were) the medium, and they (in their relationship to the other two boys) were the message. The experience might well be termed a psycho-drama which placed a series of situations in the proper combination allowing an opening of locked memories. You might refer to it as an in-depth and highly involved group therapy. Guess this is all that I can let out for now.

Have not sent polaroid along as yet. Need a couple of answers to some questions.

1. Have you ever used a polaroid camera before? This will give me an idea of how detailed to make the directions.
2. Have you (a) found anyone you can trust to help you yet, and (b) have you discussed this with him? If you have not, there is a timing device which will let you take your own shots without any help.

This letter also serves as another chance to back out of any commitment that you have made. I would not want you to become involved in anything which would bring you personal remorse, as I value your friendship too much for this.

'Pagans' Sought In Rape

FAIRFAX County police have obtained warrants and are searching for six members of the Pagan Motorcycle Club following a reported orgy at a farmhouse near Burke last week.

The complainant, police say, is a 15-year-old Arlington girl who allegedly was picked up by members of the long-haired and bearded group in Arlington Tuesday night and taken to the Guinea Road rural headquarters off There, she was repeatedly assaulted by as many as a dozen members of the organization, police reported.

Investigation into the incident, however, is hampered by only generalized descriptions of the men involved and two unidentified visitors from Pennsylvania and New Jersey in Fairfax police files. The club has been centered near the Burke community for about three months since officers of the organization took out a \$270-per-month short-term lease on two buildings located on the 60-acre Winter Hill Farm, formerly owned by Lester A. Washburn.

Washburn subsequently sold the property to the Merrick Development Corp. of Falls Church and an application for industrial rezoning has been filed on the land, which has frontage on the Southern Railroad.

Some 15 Pagan Club members occupied the buildings during the summer but the contingent has dwindled to only four following the assault and sodomy charges which were filed against the group by the Arlington girl who was identified as a Negro.

The Pagans also within the last week were visited by a group of teen-agers who fired four heavy caliber rifle shots into the home but apparently for reasons not related to the earlier incident.

Two 18-year-old Lorton area youths have been charged in connection with the shootings but five other juveniles and another 19-year-old youth are still being sought.

There have been at least two fires at the Burke headquarters in the last month, authorities reported, but the blazes have thus far been attributed only to carelessness on the part of the residents of the Pagan headquarters.

It was good to hear your voice again. I was quite surprised to be able to get in touch with you. Lately, you have been quite difficult to reach.

I hope that it didn't seem like I was talking too much in riddles last night. I want to talk with you about quite a few things, but the subject is a delicate one, and thus, I hesitate to place it in public either on the phone or on paper.

You made it a bit easier to discuss when I do see you, however. Your open minded attitude is quite helpful. If I seem overly apologetic and hesitant, it is simply that I don't want to destroy what apparently is a lasting friendship, through a misunderstanding.

There are no ifs, ands, and buts about it--I do need your help. Although what our group proposes to do is based strictly on conjecture, there is reason to believe that what we propose is possible. We are now in the process of doing a small pilot program in the hopes of getting federal funding for a more exhaustive study. We have quite a collection of abnormal data--getting a normal profile for control purposes is quite another matter.

As you mentioned, getting "into the act" might take a bit of getting use to, but I think you can handle it. If I didn't, I don't think I would even approach you. There are some conditions, however. First keep the matter confidential between us--destroying all correspondence. Second, be extremely honest (THIS IS A MUST) in answering any questions that are put to you--they may prove to be quite embarrassing, but they are necessary.

In the interest of time, there are some things that we can do early--these may help to condition you to what you might face.

1. Write a brief biographical sketch about yourself. Use the attached form, answering only those questions checked--at this time.
2. I mentioned a photograph last night that I had shown you last Xmas.
 - a. Very briefly, I want you to describe that photograph (IN PLAIN ENGLISH) and your reactions to it. Further, I want you to describe your reactions about having the same or similar ones taken of you. (This can be very brief.) *But complete!*

Can you pop these back to me in the pretty near future?
