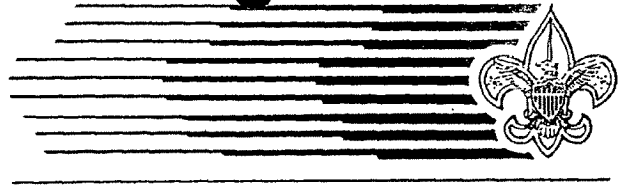

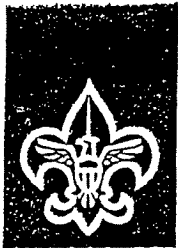

I hope this completes our file on Mr. Fields.

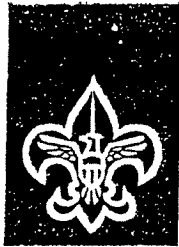

## Scout Leader Charged with Sex Crimes

Allen Lewis Fields, 26, an assistant scoutmaster of Red Hill Lutheran Boy Scout Troop, appeared in Central Municipal Court Monday on charges he engaged in sexual activities with two of his scouts.

Judge Gary Ryan held the preliminary hearing at which Fields agreed there was sufficient evidence against him to go to trial. Fields will be arraigned Nov. 12 before Superior Court Judge Luis Cardenas.

Fields was arrested Oct. 15 by Tustin police who served a felony warrant on him at the El Toro Air Station. Fields is a Marine Sergeant.

Agent Jim Hein of the Tustin police said the allegations surfaced after one of the victims reported Fields had tried to tie him to a bed in Fields' home at the McFadden Village Apartments.

The boy escaped and told his mother, who called police. In-

Hein indicated the district attorney's complaint charges Field with copulating with and being copulated by one of the victims.

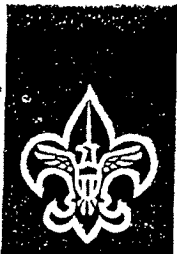

After careful review, we have decided that your registration with the Boy Scouts of America should be suspended. We are therefore compelled to request that you sever any relations that you may have with the Boy Scouts of America.

You should understand that BSA leadership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to suspend registration whenever there is a concern that an individual may not measure up to the high standards of leadership which the BSA seeks to provide for American youth. Please also understand that this decision and the reasons for it will be maintained as confidential.

If you wish to have this decision reviewed, please write to me, explaining your version of the facts supporting your claim that your registration as a BSA leader should be granted or reinstated.
