


Dear Paul:

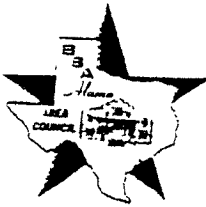



Sir,

On Friday, August 3, 1979 while I was attending the Central Area Sectional Conference at the University of Kingville, it was my impression that Alonso Heredia in a disrespectful manner.

I arrived later, at about 7:30 PM. As I walked into the reception room of the dorm, Alonso spoke to me from a distance, came over and offered to help me get situated.

After I had registered, we went out to the veranda where they were serving cakes. Alonso suggested we sit

outside because it was cooler there. People came and went off the veranda as we were sitting there. I did not know any of them since they were from other councils.

During the course of our conversation Alonzo asked me if I had read a recent article in the paper about Anita Bryant and her crusade against the "Gay Liberation" front and how open they (the homosexuals) had become.

He then asked my opinion of the article and if I understood that the were "different sexual desires".

Alonzo then mentioned "the good times he had in Austin" getting his master's degree. He said there were any number of varieties of "X-rate & XXX-movie" houses that he frequented and generally had "a good time" at.

When I asked him why he went to them he replied that he was a "sexy Mexican".

He then asked me if I had ever been to one (X-rated porno movie) and I honestly said that I had only gone when I was very young and had not been to one in the last 20 to 25 years.

He stated that while he was in the Marines, his first-sergeant was "gay" (homo-sexual) and that he had asked him to participate in homo-sexual activities. Alonso said that he accepted.

Alonso said their relationship lasted for some time until "talk" started and they decided not to see each other. As the sergeant put it, they decided to "stay away from one another".

He then asked me if I ever had

a "gay experience".

I replied that one "man" had tried and that I had broken that person's hand. I also said that I really had no use for anyone who did that sort of thing.

This remark of mine did not stop him and he persisted in his approach.

He then said, "How would you like to have sex with me?"

I was really taken aback by his abruptness. I said, "Alonso, you're kidding? I'm a married man! My wife is here!"

He said, "So what? I'm married too. With a wife, children and grand-children."

He said, "We can go to your room (I had a single room since I had arrived so late) and you can have it anyway you want it."

Oral or near-end!"

I really didn't know what say other than me that I was think about it.

Saturday afternoon after dance competition and after I had seen my wife and son, John off to their supper, danced appreciate me again.

He suggested we go somewhere together, alone, to have some coffee

I said: "No, I don't want coffee."

He then asked me if I had thought about our talk of last night.

I told him that I did not want to go to my room with him in no uncertain terms. "No Way!" as I put it.

I did not see him anymore that afternoon or Sunday. My fa

and I left that Sunday after the closing to come back to San Antonio.

I saw him again during the Ordeal on August 24th through the 26th.

Alamo had his trailer at Bear Creek and asked me if I would like to see his trailer with him.

I said I had seen trailers before.

That evening at app. 5:30 to 6:00 P.M., he asked me to forget our talk at A.S.V. and that he had made a mistake in asking me

I told him that I couldn't forget it because he was in the wiring business (Secrets) for me to forget it!

As God as my witness, the statements made in this letter are true and I am willing to take any tests as are deemed necessary

to establish my sincerity
and honesty.
