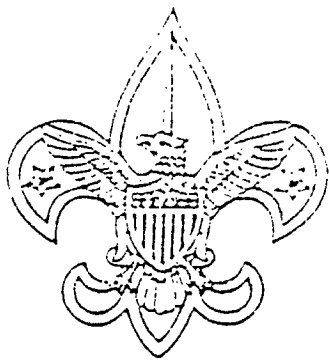

Dear Mr. Richard Heilman:

This is to advise you of an incident 2607967, reported to Medina Police concerning, Anthony J. Mollica, [REDACTED], Medina, Ohio, Date of Birth, April 27, 1962, Social Security Number, [REDACTED]

During the course of this investigation, Mr. Mollica, who represented himself as a registered Boy Scout Leader, admitted to sexual conduct with a 16 year old boy, who is NOT a Boy Scout, knowing that the boy was a juvenile.

Mr. Mollica has been charged with contributing to the delinquency of a minor.

Our investigation has established that no force was involved as was first reported. We are reporting this incident to you because of strong indications that Mr. Mollica is a pedophile with a strong preference for young boys in the 14-16 year old age group as objects of sexuality.

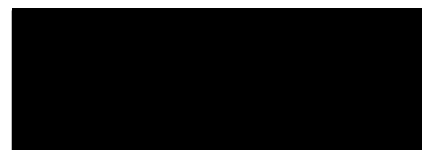
We trust that this information will be used in a confidential manner for the protection of boys involved in Boy Scouts of America programs and not subject to general release among your membership.
