March 28, 1974 - approximately 7:00 P.M.

Received a phone call from Council Vice-President, Dr. Louis H. Buechnau, D.O. 3547 S. James, Ravenna, Michigan (616-83-2561) informing me of the reported homosexual acts engaged in by a patient of Dr. [REDACTED] Muskegon, MI. [REDACTED]

Dr. [REDACTED] patient, [REDACTED] is a scout and member of the Order of the Arrow. [REDACTED] is 20 years old, retarded with the mentality of a 12 year old. [REDACTED] a longtime patient of Dr. [REDACTED] wished to sever a relationship causing him serious distress, revealed to Dr. [REDACTED] a series of homosexual acts forced on him by Arthur C. Carmean, Executive Trainee. Dr. [REDACTED] conveyed this message to me and suggested I investigate the matter as soon as possible.

March 29, 1974 - approximately 9:35 A.M.

Made contact with Dr. [REDACTED] for details from which to start investigation. [REDACTED] reported the homosexual acts began in August 1973 at Camp Gerber during an O.A. weekend and continued to December. He reported some eight incidents, involving money, an axe and a shotgun.

March 29, 1974 - approximately 10:30 A.M.

In a 2 1/2 hour meeting with Carmean, where he was confronted with the accusations, he admitted to performing homosexual acts at camp. His resignation was requested immediately with strong suggestion that he seek psychiatric help. He was also warned to stay away from [REDACTED] or a sodomy suit would be brought against him if there was any reoccurrence.

March 29, 1974 approximately 1:00 P.M.

Dr. [REDACTED] was informed of Carmean's admission of guilt, resignation and warning about any further occurrences. Dr. [REDACTED] was satisfied that we acted with decisive action and quickly to protect his patient and indicated that this should prevent any further involvement.

NOTE: Carmean is presently under psychiatric treatment and at a recent meeting in the office was reminded that he is to sever all relationships with Scouting and to maintain that status.
