# NP man gets jail time for sex offense

A 25-year-old North Platte man, having ended his treatment for being a mentally disordered sex offender, was sentenced Monday to complete the remainder of his sentence in the state penitentiary.

Arvine R. Bowen was resentenced by Lincoln County District Judge Don Rowlands to the original two-to-five-year prison term imposed in January 1988 for first-degree sexual assault on a victim less than 18 years old.

Bowen had been serving that sentence at the Lincoln Regional Center because he was declared a mentally disordered sex offender. However, the Sentencing Review Committee, while concluding that Bowen still suffered from the disorder, reported that he had not cooperated with the treatment and had received the maximum benefit of that treatment.

Rowlands ordered that Bowen serve the rest of his term at the penitentiary and gave him credit for the time spent in the county jail and the regional center. His

attorney, Kent Florom, said that Bowen will be eligible for parole soon.

Also in district court Monday, John Wise, 19, of North Platte, was sentenced to one to three years in prison for a Jan. 21 burglary of the Telegraph, 621 N. Chestnut.

Wise pleaded guilty to the charge Monday in exchange for dismissal of some pending misdemeanor cases, as well as a burglary charge that stemmed from a break-in of the Salvation Army. Wise also agreed to help authorities locate some of the stolen items.

Rowlands ordered that the prison term run concurrently with a term Wise is now serving for another burglary.

Also, Antonia Brown, 1167 S. Tabor, was sentenced by Rowlands to 18 months' probation for attempted possession of more than 1 pound of marijuana in connection with an Aug. 10, 1988, incident. Brown pleaded guilty to the charge in a plea agreement; she initially was charged with manufacturing marijuana and possession of more than 1 pound.

NOW on this 4th day of January, 1988, this matter comes on for further proceedings. Defendant appears in person and is represented by his attorney, Kent Florom. The State is represented by Kent D. Turnbull, Deputy County Attorney. The Honorable Donald E. Rowlands II is presiding.

Said matter comes on for hearing on whether or not the defendant is a mentally disordered sex offender. The State and the defendant submit the matter to the Court. The Court, based upon the report of the M.D.S.O. panel, hereby finds that the defendant is a mentally disordered sex offender and is treatable.

Said matter comes on for sentencing. The defendant is identified. The presentence investigation report is reviewed by the Court and by counsel. The Court finds the defendant guilty of First Degree Sexual Assault. The defendant makes a statement in mitigation. The Court makes a statement. There being no sufficient reason having been given why sentence should not now be pronounced, the Court finds that the defendant should be sentenced to the Nebraska Penal and Correctional Complex for a term of not less than two (2) years nor more than five (5) years.

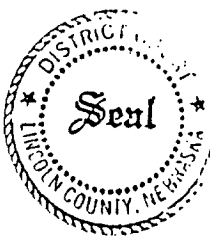
IT IS THEREFORE ORDERED that the above named defendant be, and he hereby is, sentenced to the Nebraska Penal and Correctional Complex for a term of not less than two (2) years nor more than five (5) years, with credit for time served. The Court further finds that under Section 29-2915 the defendant is a mentally disordered sex offender, that the disorder is treatable and that such treatment is available in this state and the Court does commit the defendant for treatment at the Lincoln Regional Center until such time as the Court determines, based upon the reports filed by Sentencing Review Committee established under Section 29-1916 that the defendant is no longer mentally disordered, or until the defendant has received the maximum benefit of treatment, specifically except that this treatment will not be longer than the sentence imposed in this matter. All Costs are taxed to the defendant.

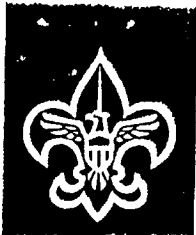



## Hearing to be scheduled in carnival stabbing case

A hearing is to be scheduled in Lincoln County Court on a defense motion to transfer to juvenile court the case of a 17-year-old North Platte male accused of a June 15 stabbing at a carnival near the Wild West Arena.

The youth was jailed Wednesday on an arrest warrant charging him with first-degree assault and use of a deadly weapon to commit a felony. The victim, Timothy J. Timmermans, 18, 2120 William, was stabbed twice in the chest and once in the abdomen, according to court records.

Timmermans was dismissed from the hospital Monday morning.

The youth remains in the Lincoln County Jail.

In other county court action Monday, Arvine R. Bowen, 24, 813 W. 11th, was charged with first-

degree sexual assault for allegedly subjecting a person younger than 16 to sexual penetration on June 14. Bond was set at 10 percent of \$25,000, with no contact permitted with the alleged victim.

A preliminary hearing for Bowen, who was arrested Friday by North Platte police in connection with the case, has been scheduled for 9:30 a.m. June 29. He remains in county jail.

Glenn C. Cheever, 24, East Tryon Route, was charged Friday with misdemeanor procuring alcohol for minors and felony third-degree assault on a police officer. Cheever was arrested June 12 in connection with the case and released from county jail June 13 on 10 percent of a \$3,000 bond. A preliminary hearing has been scheduled for 10:30 a.m. June 30.
