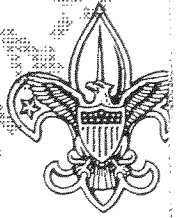
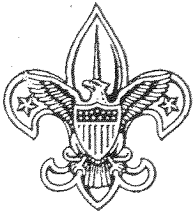

Dr. [REDACTED] contacted Clifford G. Walters, District Commissioner, and explained to him that he had heard that a few boys at Scout camp did not stay two weeks as planned, but left camp after only one week. He explained that he heard that this was due to a "short arm" inspection. In investigating this, we found it consisted of individual boys going into the Scoutmaster's tent, flap closed, and being examined by feeling the stomach, testicles, and generally in that area. This happened many times during the week. It was also verbally suggested that perversion denotes manhood by the Scoutmaster Austin Murphy. This man, because of strange happenings at week end camp trips, has been watched for two years. This information was substantiated by the enclosed statement by a Scout who was in camp.
