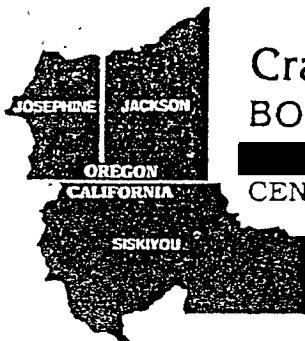

Dear Paul:

On June 21, 1988 at approximately 4:30 p.m., Sgt. Ron Jones of the Oregon State Police, and I, met with Robert Frederick Drake, Sr. at the State Police office in Grants Pass, Oregon.

Sgt. Jones informed Mr. Drake that after our District Day Camp Staff Training on child abuse, a volunteer reported to the Camp Director that she knew Mr. Drake had sexually abused [REDACTED] back in the late 1970's. Sgt. Jones further told Mr. Drake that he had checked on this accusation with the Grants Pass Police Department and they verified that the accusation was correct. They also verified that Robert Drake's son, Benjamin Drake, had also sexually abused [REDACTED] and this abuse took place from approximately 1973 to 1979.

At this point Sgt. Jones had me read the attached letter to Mr. Drake suspending his registration with the B.S.A. I then gave Mr. Drake a copy of appendix D and briefly explained the procedure to request a review. I also gave him \$5.00 cash to refund his registration fee.

I request that Robert Drake, Sr. be placed in the confidential file. As soon as we can find Robert's son, Benjamin Drake, we will deliver a letter to him suspending his registration with the B.S.A. and request that you also place him in the confidential file.

I have enclosed confidential record sheets for both individuals as well as the complaint report we obtained from the Grants Pass Police Department.

If you need additional information, let me know.

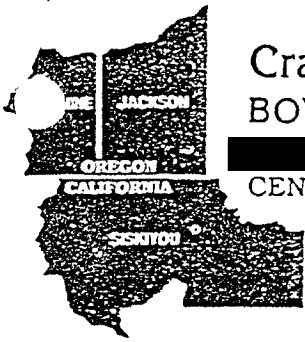

After careful review, we have decided that your registration with the Boy Scouts of America should be suspended. We are therefore compelled to request that you sever any relations that you may have with the Boy Scouts of America. A refund of your registration fee is enclosed.

You should understand that BSA membership is a privilege and is not automatically granted to everyone who applies. We reserve the right to suspend registration whenever there is a concern that an individual may not meet the high standards of membership which the BSA seeks to provide for American youth.

If you wish to have this decision reviewed by a council review committee, please write to me within 60 days of the date of this letter, explaining your version of the facts supporting your claim that your registration as a BSA member should be reinstated. The procedures for a review of this decision are attached.

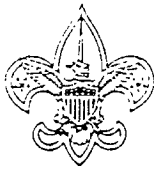

but also oral copulation and anal sex with her. Victim was asked if she was willing to take a polygraph test and she stated that she would be willing to do so, and she also stated that she would testify in front of a jury if necessary, as she is tired of having to submit to sexual relationships with the above two suspects.

A polygraph test will be scheduled for the victim.

7-20-79 The victim [REDACTED] was given a polygraph examination on 7-12-79 in reference to the sexual intercourse with [REDACTED] Robert Drake, the results of the polygraph examination was that she is telling the truth.

On 7-19-79, the results of the above mentioned polygraph examination were turned over to Josephine County Deputy D.A. Scott Bridges who then contacted Robert Drake's attorney, Charlie Seagraves. Mr. Seagraves and Deputy Bridges agreed that no charges would be brought against Mr. Drake providing he seek psychiatric help and give up legal custody of the victim [REDACTED] Children's Services Division counselor, Dan Converse was advised of the situation.
