

Gentlemen:

Please withdraw the commission, and place in the confidential file Mr. Benjamin Franklin Midgette, Troop Committee Member, Troop 67, District No. 2, Mobile, Alabama, whose home address is 512 Azalea Road, Mobile.

Mr. Midgette is a Catholic, age 34, and is currently employed with the Ruberoid Company in Mobile. He is married and is the Tether of four children.

According to the state parole officer in Mobile, Mr. Midgette was convicted on July 26, 1963 of a charge of "felonious tresspassing" (peeping tom) and sentenced by Judge Darwin W. Maples to five years in the state penitentiary and the sentence was suspended and he was on probation in Mobile, apparantly his home city.

According to our information, the man is an exhibitionist with unnatural sex tendencies. On July 27, 1965, he was arrested on a charge of indecent exposure by the Mobile Police Department, offense report no. 31974, tried, found guilty and sentenced to 30-days in jail and fined \$150.00. He has now appealed, but the probation officer and his family states that this is, in their opinions, stalling for time. They are trying to get him committed to a Veteran's hospital.

The complaint stated that he was dressed only in a tee shirt, in his automobile in the parking lot of a school, attracting the attention of girls leaving summer school classes while he was participating in an unnatural sex activity.

The offense report is more detailed and specific, but this should be sufficient for withdrawal of the commission of this individual.
