
Dear Paul:

Present: Tom Moore, Scout Executive, Choccolocco Council
Rick Burnham, Executive Board Member and Council Attorney
Bobby Strickland, Cubmaster, Cub Scout Pack 132

Meeting was held with Mr. Strickland on the above date in regard to alleged sexual child abuse reported to the Scout executive of the council on October 6, 1987. [Written statement of allegations presented verbally on October 6 is enclosed.]

Mr. Strickland was presented with a letter signed by the Council president informing him that his registration with the Boy Scouts of America should be suspended. [Letter used was taken from Appendix B, Page 15, of the Boy Scout booklet on "Sexual Child Abuse."] Mr. Strickland was also presented a copy of the procedure required for requesting a council review of his registration. [Appendix C, Page 16, of the Boy Scout booklet "Sexual Child Abuse."]

Mr. Strickland was told only that the council had received evidence to convince it that his personal and moral life did not meet the standards of membership in the Boy Scouts of America. He was told this information was confidential and that the council only wished him to stop all Scouting activity. He was informed of his right to seek review of his case, using Appendix C as mentioned above.

Mr. Strickland's verbal reply to the letter was to ask for the circumstances that led to this meeting and who had accused him of wrong doing. Our response again was that the evidence presented to the council was confidential and according to guidelines set forth by the Boy Scouts of America, we were not obligated to reveal either the circumstance or the names of individuals bringing the allegations. He again was told of his right to seek review by a council committee.

Mr. Strickland agreed to remove himself from Scouting and to assist with the recruitment of his Assistant Cubmaster to fill his vacated position.

As a result of the written allegations enclosed, the Choccolocco Council requests that Mr. Strickland be placed in the CONFIDENTIAL FILE. [Confidential record sheet is enclosed.]

Dear Miss:

I'm writing this statement for my son [REDACTED]. He came home from a camping trip this past summer with Bob Strickland and the Cub Scouts crying. He told me that he hated Cub Scouts and he didn't want to have to go back. I sat him down and asked him what had happened. He told me that while he was sharing a tent with Bob and [REDACTED] that something had happened. At first [REDACTED] and [REDACTED] was sharing the same bed. [REDACTED] woke up and told Bob that he was cold, Bob told him to come over to his bed with him. Not knowing what Bob had

in mind, [REDACTED] went over to
Bob's bed. After he got in
Bob's bed, Bob started rubbing
his leg and went on up to
his private part, Bob then took
off [REDACTED] shorts and then
took his own off. Bob then
took [REDACTED] hand and
put it on his (Bob's) private
part and told him to shake
it for awhile.
