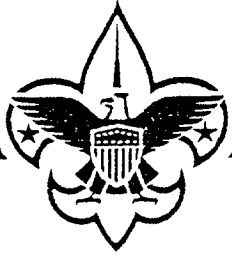

O R D E R

On the 22nd day of December, 1988, came the Defendant, in person and with his retained Attorney, Robert C. Boswell, Esquire, and came the Attorney for the Commonwealth and the Court Reporter, pursuant to a previous Order of this Court setting this case for trial by felony venire on Thursday, December 22, 1988, on an indictment charging the Defendant with committing aggravated sexual battery.

WHEREUPON, Defense Counsel moved for leave of Court to withdraw the Defendant's prior plea of "not guilty" and allow the Defendant to enter a plea of "nolo contendere". The Court proceeded to examine the Defendant to determine the voluntariness of his intended plea of nolo contendere. Being satisfied with the answers to the questions propounded to the Defendant that his intended plea would be voluntary, with an understanding of the nature of the charge herein and the consequences of a plea of ^{guilty} guilty, the Court sustained Defense Counsel's motion and directed the Clerk to re-arraign the Defendant.

WHEREUPON, the Clerk of the Court read the indictment to the Defendant, who entered a plea of nolo contendere to the indict-

ment herein, which said plea was accepted by the Court. The Attorney for the Commonwealth presented evidence by the testimony of the investigating officer and the introduction of an exhibit. The Defendant presented no evidence in his behalf at this time and Defense Counsel moved the Court that this case be referred to the Probation Officer for a pre-sentence investigation and report.

WHEREUPON, without objection, the Court orders this case referred to the Probation Officer for a pre-sentence investigation and report, returnable on Thursday, February 9, 1989, at 9:00 A.M. and the Defendant's bail bond and recognizance is continued until that time and date for further proceedings.

Dear Mr. Boswell,

I have seen Mr. Coffey October 4, 1988, October 21, 1988, October 31, 1988, and November 10, 1988. He was seen by Thomas C. Camp, Ph.D. November 14, 1988 and November 18, 1988. Neither I or Dr. Camp found any evidence of a psychiatric illness. Mr. Coffey has traits of a mixed Personality Disorder. These are enduring patterns of perceiving, relating to, and thinking about the environment and oneself, but, I do not think this has any bearing on the issue.


I found no evidence of a sexual disorder that would lead Mr. Coffey to be a future threat to society.

My expectation is that Mr. Coffey will strive to continue his education, marriage and the usual normal things of life.

I have no specific recommendation for treatment of Mr. Coffey. He may find that psychotherapy or counseling would afford him an opportunity to be more expressive.

Man Pleads No Contest In Molesting Of Scout, 11

A Blacksburg man pleaded no contest Thursday in Frederick County Circuit Court to a charge of aggravated sexual battery against an 11-year-old Boy Scout.

Bradley Martin Coffey, 24, a scoutmaster at the time of the incident, will be sentenced Feb. 9.

John Snoots, an investigator for the Frederick County Sheriff's Department, testified that the incident occurred at Camp Rock Enon in Gore during the early morning hours of Aug. 5.

He said an 11-year-old boy attending the camp was hit in the head with an oar in an accident on the afternoon of Aug. 4 and that Coffey took the boy to the hospital.

Snoots said the boy underwent X-rays and that his doctor said he should be awakened every two hours to check the effects of his head injuries.

In a statement made to police, Coffey, who said he is working on a doctoral degree, said he slept in the same tent as the boy that night.

Coffey told police he first awakened the boy at 2 a.m. and that he complained of being hot.

According to the statement, "I thought it would be best for (the boy) to remove his clothes so he wouldn't be so hot, and I helped him undo his pants and pulled his scout shorts off and socks off and pulled his sleeping bag back some from him."

In his statement, Coffey said the boy told him he was sore, so he massaged his legs.

Then he touched the boy, who was wearing underwear, in the groin area for about 30 seconds, Coffey said.

Two hours later, when he awakened the boy again, he started to touch him in the same manner, Coffey said, but the boy told him to stop.

Coffey said he stopped and went back to bed with feelings that he had done something "pretty wrong."

Coffey told police a similar incident happened to him when he was 12. During the summer, he said, some neighbor boys held him down on several occasions and fondled him.

"I knew I didn't like it, you know there's kind of conflicting emotions in that, you know this is a bad thing," he told police. "This is something that I don't want them to be doing, but why does it feel good. . . ? It's kind of a warped type of pleasure."

Snoots testified that later on Aug. 5 the boy called his parents and told them about the incident and that they contacted the sheriff's department.

Coffey could be sentenced to up to 20 years in prison.

In other court action:

• David Michael Stonebreaker, 21, of Paw Paw, W.Va., was sentenced to an eight-year prison term, suspended, and to two year-long jail terms—to be served concurrently for two break-in charges and two charges of grand larceny.

He was also ordered to pay \$100 in restitution and court costs.

• Rebecca Lynn Funk of Highland Avenue pleaded guilty to a charge of trying to sell cocaine to an undercover officer at the McDonald's restaurant parking lot on U.S. 11 North.

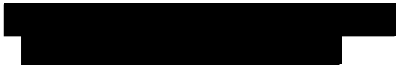

Shotgun Incident: Man Indicted

Timothy Grimes, charged with shooting his brother in the face with a shotgun, was indicted Thursday by a Frederick County grand jury on charges of malicious wounding and felonious use of a firearm.

Grimes, 20, is being held in the Frederick County jail on \$25,000 bond.

His cases will be continued until he takes an examination to determine his mental state at the time of the alleged offenses and if he is competent to stand trial.

Public Defender William Crane was appointed to be his attorney.

During a preliminary hearing last month in Juvenile and Domestic Court, Tommy Grimes, 25, of Berryville, testified that his brother shot him in the face June 20, at their aunt's house on Redbud Road in Frederick County, when he told him he was unable to pay back immediately \$900 that he owed him.

Timothy Grimes was one of the three black victims in the December 1986 Howard Beach, Queens, racial fight with several white teenagers. One of his two

companions was killed in the incident.

During the two trials of the white teenagers, charged with assault and manslaughter, Grimes cursed and spit on the witness stand.

A prosecutor in the latest trial said Grimes had been diagnosed by a psychiatrist as suffering from "acute psychosis."

Also indicted Thursday were:

- Bradley Martin Coffey on a charge of sexually molesting a child younger than 13 Aug. 5.
- Benjamin Howard Spiker on two charges of grand larceny—in the July 24 theft of a 1978 Pontiac owned by David S. Hosey, and the Aug. 7 theft of a 1974 Chevrolet owned by Polly's Cab—and a charge of robbery in the Aug. 7 theft of money from Dennis Hopkins.
- Terry Foreman on a charge of stealing a credit card from Wendy Roberts May 3.
- Donna Alice Bockey on a charge of grand larceny in the theft of more than \$200 from Aikens Investments May 19, 1986, through Aug. 29, 1988.
- Richard David Ruby on a charge of possession of marijuana with the intent to distribute May 10.

IS UNDERSTOOD THAT:

During the period of training, the staff member's full time is at the disposal of the camp. Each day presents certain opportunities for personal recreation and program participation. During each week, time off may be arranged by conference with the camp director and as the camp's program and the staff members' responsibilities permit.

The staff member agrees to spend at least one weekend (if needed) at camp during the camp season in order to make sure that the camp is at a peak of readiness for the campers the following week or for an overnight program weekend.

While the specific functions designated may be his chief duties, the staff member agrees to help forward the entire program and objectives of the Boy Scouts of America, assisting it in such manner as assigned now or at a later date by the camp director.

Staff members will come to camp one week in advance of the opening day (pre-camp staff week) for training and preparation of the camp.

The Shenandoah Area Council is not responsible for personal items belonging to the staff members.

Staff members must have a completed Boy Scouts of America Medical form as per their age requirements and the requirements of the Boy Scouts of America. This form is needed at least one week before the opening of Staff Week. Appropriate medical form will be provided by the Shenandoah Area Council. Medicals are at the expense of the staff member.

The staff member has read and agrees to his job description and other information in the staff guide book (attached).

If you wish to have this decision reviewed by a Council review committee, please write to me within sixty (60) days of the date of this letter, explaining your version of the facts supporting your claim that your registration as a Boy Scouts of America member should be re-instated.
