I, the undersigned complainant, being duly sworn, state the following is true and correct to the best of my knowledge and belief. On or about May 19 or 20, 1989 Berkeley County, West Virginia, the defendant(s) did, (state statutory language of offense)

Sexual Abuse - 1st Degree

in violation of W.Va. Code § 61-88-7. I further state that this complaint is based on the following facts: Upon information the victim [Redacted] age 10 [Redacted] was sexually abused by the defendant while the victim [Redacted] and his younger brother were camping with the defendant. The camp was at The Boy Scout Spring Camporee. Which was held on the Bill Aikens Property located off [Redacted] at a location of [Redacted] miles west of Route [Redacted], Falling Waters District, Berkeley Co. W.Va. While sharing a tent with [Redacted] and Bruce Church, Bruce Church abused [Redacted] by putting his hand down the front of the boys pants and in his under ware and fondled him for what the victim describes as a half an hour. The victim tried to pull the defendants hand out during the time, but was unable to remove his hand. When the defendant removed his hand he told the victim not to tell his parents about what had happened. The [Redacted] was asleep during the incident but was present in the tent during the incident. Bruce Church is reported to be approx. 21 yrs. old.

• Bruce E. Church, 20, of Hedgesville was arrested Wednesday afternoon on a charge of first-degree sexual assault, according to Chief Deputy John Vanorsdale.

According to Berkeley County Magistrate Court records, Church is accused of fondling a 10-year-old Berkeley County boy during a Boy Scout Camporee in May in Falling Waters.

Church was arraigned before Berkeley County Magistrate Harold "Gene" Darlington and released on a \$2,500 bond.

Vanorsdale said someone broke into Top 20 Videos in Inwood Wednesday night and stole \$150 in cash. Thieves made their way into the store by prying open a back door, he said. Shop owner George Whitehair said the \$150 in cash was to be used to start the next day's business.

• Cheryl B. Kesecker, 31, of Route 1, Bunker Hill, is in satisfactory condition at City Hospital after she was involved in a single-car accident on Interstate 81 early Thursday morning.

Kesecker was traveling south on I-81 near the Winchester Avenue exit when she ran off the left side of the road, into the median and struck a concrete drain, according to Vanorsdale. Berkeley Springs Water Is Her Li

BERKELEY SPRINGS — Gladys Whittington really enjoys her job. So much so, that during the past three decades she has never really considered quitting her job as an office worker for the town's water department.

Even now, when she could consider retirement after 30 years service, the thought doesn't enter her mind — at least not too often.

In June 1959, Whittington first started working as a clerk for the town's water department, which was then owned by a Washington, D.C., company.

"When I first started working for the water department, my job was to collect the money when customers came in to pay their water bills," she said.

Thirty years later, Whittington finds her responsibilities including billing, filing and bookkeeping, as well as being a secretary. "Now I do everything. I'm a Girl Friday now," Whittington said with a laugh.

The work associated with her job has remained basically the same through the years, but the amount of work has increased. When she started, the town had 600 water customers. Now the town has 1,200 customers, she said.

Whittington still uses an old manual billing machine to produce the water bills, which are mailed quarterly. "It's a cheap way, but a good bit of work is involved with it," she said. "They are now thinking about going to computers. They told us they're having trouble getting parts now for the billing machine."

Water customers can count on receiving water bills. "Our billing has always gone time in the 30 years that I've been here quite a record," Whittington said proudly.

Her favorite part of her job is meeting public. "In fact, that's why I don't retire," she said.

Customers, especially the elderly, like when they come in to pay their bills. Whittington said. "Old people like to get out to pay their bills."

Through the years, many customers brought their children with them to pay their bills. "Now those children who used to come in with their parents in the past come in and bring their own money," she said.

While she likes to prepare the bills and collect them because she looks forward to seeing when they come in to pay, the worst part of the job is collecting money from people with financial difficulties. "There are people who don't have the money. There's some people that do have the money but they don't have time paying," she said.

Most of the time, her job has been routine. It allows her to work at her own pace. Whittington said. However, customers, who for the most part are nice, have disrupted the routine at times by creating some memorable moments, Whittington said.

For instance, one day after a man paid his water bill, he walked out the door and stepped off the curb and fell over dead. Whittington said.

Whittington still has no definite plans as to when she's going to retire. "I'm taking it day by day," she said.
