

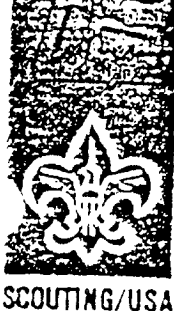


Dear Mr. Galbraith:

Man pleads not guilty to 12 counts of child rape

GREENFIELD — A Boy Scouts of America volunteer who pleaded not guilty in Franklin County Superior Court to 12 counts of rape of a child under age 16 has been released on \$1,000 bail.

Judge William Simon Thursday released Bruce E. Galbraith of Gill on condition that he stay away from the alleged victims and from the Boy Scout troop for which he had volunteered.

Galbraith is charged with forcing two youths to have "unnatural sexual intercourse" with him on nine different occasions on or about Aug. 14, according to court records.

An Oct. 16 pretrial conference was set.
