IT IS HEREBY ORDERED that a Probation officer of the Department of Corrections prepare and present to the court a pre-sentence investigation report on the defendant; and

IT IS FURTHER ORDERED that the defendant report to the Regional Office, Office of Probation and Parole, [redacted] Seattle, Washington (Telephone: 464-7966) on the 16th day of May, 198 5, at 1PM M., with the information sheet provided herewith. (If defendant is in custody, an officer of the Office of Probation and Parole will contact him in the King County Jail); and

IT IS FURTHER ORDERED that the date for judgment and sentence is hereby set for the 25th day of June, 198 5, at 8:45A.M., before the undersigned judge.

DONE IN OPEN COURT this 6th day of May, 198 5.

IT IS FURTHER ORDERED that all juvenile investigative and arrest records, and all mental health records pertaining to the defendant be made available to the Probation Officer of the DSHS; such information shall be held confidential except for the purpose of said Presentence Investigation Report prepared and presented to the court.
