My conclusion is still the same as previously. I will not approve this man's registration in the Boy Scouts of America.

The less you know personally about the case, the better. Our advice is to tell Mr. Martin that the National Council of the Boy Scouts of America does not wish to accept his registration. You should indicate to him that registration in the Boy Scouts of America is a privilege and not a right and that the National Council reserves the prerogative to accept those individuals it feels will best serve the interests of the Boy Scouts of America.

It is hard for me to understand as to why a confidential questionnaire was not first sent about Mr. Martin. You are informing us about Mr. Martin directly this way leads to two questions:

1. How are you sure that C. Paul Martin of Crescent Bay is the C. Paul Martin referred to in your letter without first sending through your questionnaire?
2. Mr. Martin was registered as a Committee member of Troop 7 in Santa Monica District Dec. 1948 to Jan. 1950. He was a Committee member of Troop 126 in 1965. He was Scoutmaster of Troop 324 in Stuttgart, Germany 1966-late 1969 Trans Atlantic Council, from which he returned with glowing letters of approval from the Commanding Officer and the Scout Executive of the Trans Atlantic Council. Can this possibly be the same man?



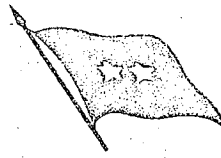

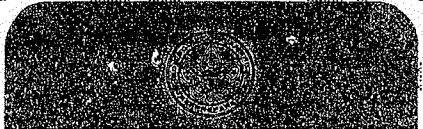

HOW TO FILL OUT THIS APPLICATION FOR A TROOP CHARTER

REQUIREMENTS FOR ADULT REGISTRATION

Institutional representative.—The institution shall select one of its male members other than Scoutmaster or assistant, to register in this position for the troop and any other units the institution sponsors.

Troop leaders.—The troop must have three male committeemen 21 years of age or over, with one named chairman. The Scoutmaster must also be 21 or older, while assistant Scoutmasters may be 18. The troop must have a minimum of five boys.

NOTE: Complete the following information from top left corner:

ADULT AND BOY ROSTERS

Unit status.—Indicate status of troop as N—new, R—re-registering, S—separated-re-registering. Complete the rest of this line (except the four spaces "For Office Use Only!").

Name column.—Print or type full name (first name, initial, last name). Then complete address and city columns.

State and Zip code.—Use the new two-letter post office abbreviation for your State followed by your Zip code. Example: NJ 08903

Age column.—List each applicant's age. Boys must be 11 and under 18 years old.

Boys' Life column.—Mark "X" in column for all boys and leaders who are paying for Boys' Life. On Scoutmaster's line mark "S" for complimentary subscription (enter on COMPLIMENTARY line at top of "Boy Roster") or "C" for cash commission, if either is applicable (see "Boy Roster" directions).

Status column.—Indicate individual status of boy or leader as N—new (first time registered), R—re-registering, S—separated-re-registering, T—transfer, M—multiple (for adults only), or B—new Boy Scout, formerly a Cub Scout (for boys only).

Former unit column.—If boy or leader has current unexpired registration card from another unit, and the status is "T" or "M," list former unit with unit initial (P—pack, T—troop, E—post) and its number.

Partial fee column.—If boy or leader is transferring from another unit and paying other than normal fee, indicate fee being paid.

ADULT ROSTER

Organization or group of citizens.—Give full name and address of institution or group; initials or abbreviations cannot be accepted. Institution is obligated to provide adequate facilities, supervision, and leadership and to help provide Boy Scouts with the opportunity for a year-round outdoor program including 10 days and nights of camping during the 1-year registration period. If unit is a neighborhood patrol, write "Neighborhood Patrol" in this space.

Institution head.—Give full name, title, address, and telephone.

Scoutmaster trained.—Check this line if Scoutmaster is fully trained.

Sex column.—Indicate M for male. Females cannot register with troops.

Telephone B or H column.—Give telephone number and indicate if number is B for business or H for home. Example: (B)249-6000

Position column (POS.).—Use the following code letters to indicate leaders' positions and list in this order:

- IR — Institutional representative
- CC — Chairman
- MC — Committeeman
- SM — Scoutmaster
- SA — Assistant Scoutmaster
- GR — Guarantor (for neighborhood patrol only)

U.S. citizen column (U.S. CIT.).—Indicate citizenship as Y—U.S. citizen, D—declaration of intention, or N—other (visiting adult aliens must indicate country of citizenship, last address there, and any previous Scouting record in a note attached to this application).

Religious preference column (REL. PRF.).—Adults mark this column as B for Buddhist, C for Roman Catholic, J for Jewish, M for "Mormon," O for Orthodox, P for Protestant, and X for other faiths.

All adults must sign application on left side portion, using full name (first name, initial, last name). Institution head and local council representative must also sign in spaces provided.

BOY ROSTER

Boys' Life Subscription and Registration fee information.—Total the number of Boys' Life subscriptions for boys and adults, both paid and complimentary. If there are 10 or more paid subscriptions on initial troop order for current year, the Scoutmaster is entitled to a complimentary 1-year subscription or a cash commission of \$2 (or pro rata subscription term or commission).

In setting subscription term (months), plan for Boys' Life to expire 2 months beyond troop charter expiration date. This ensures uninterrupted service during next registration period.

Secure registration fees at yearly rate of \$2 per adult and \$1 per boy. Boys' Life fee is \$2 per person. Fees must accompany charter application—payable to the local council, Boy Scouts of America.

Other information.—Complete other details requested in top portion.

Complete columns as stated in "Adult Roster" directions.

Rank column.—Boy Scout ranks are indicated as T—Tenderfoot, 2—Second Class, 1—First Class, S—Star, L—Life, and E—Eagle.

HOW TO FILL OUT THIS APPLICATION FOR ADDITIONAL ENROLLMENT

Complete top line of application, give unit status as "A."

Complete Boys' Life Subscription and Registration fee information on "Boy Roster" using rate table which follows.

Complete all necessary columns as given in HOW TO FILL OUT THIS APPLICATION FOR A TROOP CHARTER.

On adult form complete the following details:

Adult approval.—The application of Scoutmaster or assistant Scoutmaster must be approved by troop committee chairman. Application for institutional representative or committee must be approved by institution head. Approval is indicated by appropriate signature on "Institution Head" line on left side portion of application.

Scoutmaster trained.—Check the space if new Scoutmaster is fully trained.

"If no boy registrations" box.—If no boy applications are included, indicate adult fees and number of months registered (plus requested Boys' Life information if any subscribers).

Partial fee column.—Since additional enrollment probably is not for entire year, fill in partial fees as found in following table.

In determining the number of months to pay for, begin with the month the boy joins and end with the expiration month of the unit.

EXTRACTS FROM THE CHARTER AND BYLAWS OF THE BOY SCOUTS OF AMERICA

Granting Commissions and Certificates of Membership

All persons serving in any official relationship with the Boy Scouts of America shall subscribe to the statement of religious principle . . . the Scout Oath and Law, and these Bylaws. Such persons shall be citizens of the United States, or . . . shall have legally declared their intentions to become citizens of the United States, or, in the case of minors, shall take an oath of allegiance to the flag and Government of the United States, or shall satisfy the requirements of Article XVI, Section 6, Clause 4 with respect to visiting adult aliens. Article XVIII, Section 2.

Character Development, Citizenship Training, Mental and Physical Fitness

The purpose of the Corporation is as set forth in the original certificate of incorporation under the laws of the District of Columbia, dated February 8, 1910, and restated in the Act of Incorporation enacted by the Congress of the United States of America on June 15, 1916, as follows: "That the purpose of this corporation shall be to promote, through organization, and cooperation with other agencies, the ability of boys to do things for themselves and others, to train them in Scoutcraft, and to teach them patriotism, courage, self-reliance, and kindred virtues, using the methods which are now in common use by Boy Scouts." In achieving this purpose, emphasis shall be placed upon its educational program and the oaths, promises, and codes of the Scout program for character development, citizenship training, mental and physical fitness. Article I, Section 2.

Declaration of Religious Principle

The Boy Scouts of America maintains that no boy can grow into the best kind of citizen without recognizing his obligation to God. In the first part of the Scout Oath or Promise the boy declares, "On my honor I will do my best to do my duty to God and my country and to obey the Scout Law." The recognition of God as the ruling and leading power in the universe and the grateful acknowledgment of His favors and blessings are necessary to the best type of citizenship and are wholesome precepts in the education of the growing boy. No matter what the religious faith of the boy may be, this fundamental need of good citizenship should be kept before him. The Boy Scouts of America therefore recognizes the religious element in the training of the boy, but it is absolutely nonsectarian in its attitude toward religious training. Its policy is that the home and the organization or institution with which the Scout is connected shall give definite attention to his religious life.

Only persons willing to subscribe to this declaration of principle shall be entitled to certificates of leadership in carrying out the Scout program. Article II, Section 2.



I am writing this letter to you in my Boy Scout capacity as Chairman of the Troop Committee for Troop 324 at Patch Barracks. We have had the unfortunate circumstance of determining through official investigation that Mr. Paul Martin, our previous Scoutmaster, was a homosexual and was involved in assaults on some of the Boy Scouts. Mr. Paul Martin was the Scoutmaster, Troop 324 Patch Barracks, Stuttgart-Vaihingen, Germany. In confirmation of the reports I am attaching statements from two of the parents involved as official evidence of the parents' views and knowledge of this situation.

I am deeply concerned that because of the circumstances in this case, Mr. Martin, who has since departed Germany for the United States, may attempt to make contact with boys through Boy Scout troop activities. I understand that this can be prevented by having his name entered on a register for such things which is distributed throughout the Boy Scout system. I am further informed that you can take the necessary action in this case and I would be grateful if you would do so and confirm back to me receipt of my letter and completion of the necessary action so that I may inform parents who have asked me that such action has been taken.

This correspondence is intended to inform the Boy Scouts of America, National Headquarters of my personal feelings concerning the case of Mr. Paul Martin, ex-Scoutmaster, Troop 324, Patch Barracks, Stuttgart/Vaihingen, Germany.

There are confirmed reports that Mr. Martin is a homosexual and should be barred from participating in any BSA activities in the future. As you know my son, [REDACTED], was personally involved in this sordid situation.

As a committee member, parent, and ex-Scout I feel it is imperative that a person of this type be prevented from close association with boys in the future. I know that Mr. Martin has been involved in Scouting for many years and would attempt to continue this association in the future if possible.

Mr. Martin was invited to leave this troop and Europe on or about 18 September 1969 and returned to the United States supposedly. He works for the Planning Research Corporation in Los Angeles and lists his mother's address as 2825 Granville Avenue, Los Angeles, California 90064.

I would appreciate expeditious handling of this matter to prevent the parents and committee of another Boy Scout Troop going through a similar traumatic experience.
