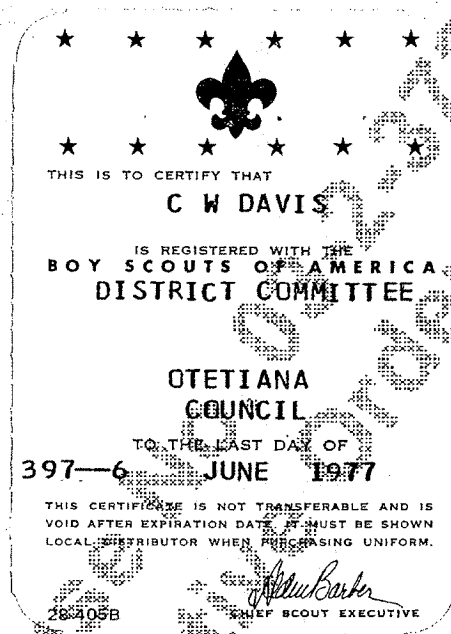

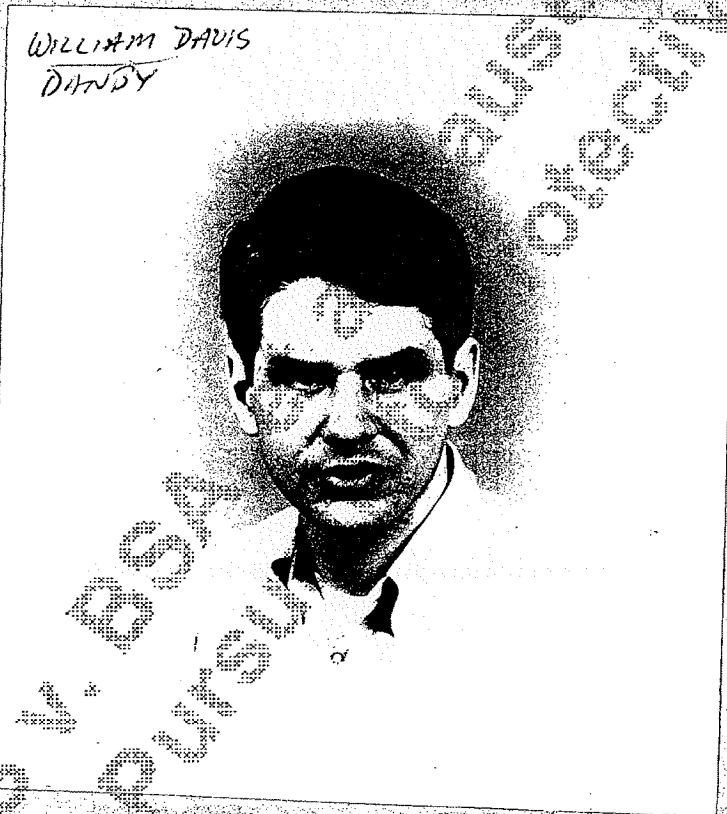

As you will recall when we discussed this with Ayrand Adams, the attorney has been defending him. He said that he would attempt to remove the case with the Air Corps.

When I talked with Davis in June he had no knowledge of any effort in this regard.

Meanwhile he is active in the unit and also in Indian dancing which the last evening showed up at our weekly swim class.

His presence at these events disturbs me inasmuch as his service record shows it is plus some comments that he made to boys while serving as a Unit Leader at Camp Barton the summer of 1957.

Dear Bill:-

Last week we discussed the unpleasant experience which occurred at the Naval Reserve Station in connection with a training session of the Dance team at their station last July. This situation was put in writing by [REDACTED], "Duty watch Stander" to you on 26 Dec. 1967.

On Friday 2 Feb. I went to the Naval Reserve Station. [REDACTED] was not there but was expected Tues. 6 Feb. Today I called again and talked with him about the July affair. He gave me about the same information he had given you earlier. Said he had been a Scout himself and was much disappointed to see boys engaged in throwing and breaking pop bottles and had ordered them to leave. He said he did not know the name of the leader who mustered up ~~the following~~ comments which could not be understood as they left ~~the following~~

He pointed out that most people who use the facilities check in and report their presence and show some appreciation but that this group had not extended this courtesy.

He thinks that your talk with the group was helpful. No unfavorable report has come to his attention since that time. (I got the impression he may have been away some in recent months and I do not know how frequently the Scouts use the Naval Reserve Station.)

Apparently this group ^{is} quite willing to make ^{available} their facilities for use by appropriate groups such as older Scouts but they are very scrupulous about having things carried with order and purpose.

It seems clear that the leadership, who ever was responsible, was not effective or acceptable on the occasion last July. However, I found no evidence of unacceptable conduct on any occasions when scouts may have been there since that time. Never-the-less, I believe it is important for scout leaders and scouts to recognize that this is public property and that we all have reason to be appreciative and acceptable guests whenever we use the facilities.

With this note I return the letter [REDACTED] wrote to you on 26 Dec. 1967.

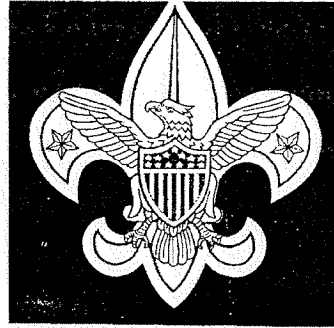

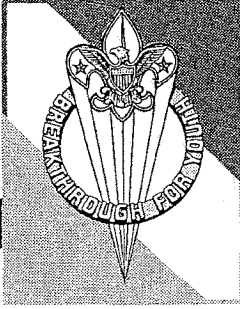
Dear Sir:
