DEAR MR. BAKER,

THIS LETTER IS REFERENCE TO OUR RECENT CONVERSATION CONCERNING MR. CASEY MURPHY. I MET CASEY WHEN I WAS TWELVE YEARS OLD (1974) AT CAMP ORR. I STAYED A SEVERAL WEEK OF CAMP AFTER MY TROOP LEFT, WITH THE BOOBY BEARS (CAMPERS WITHOUT TROOPS) CASEY MURPHY WAS THE LEADER. CASEY TALK TO ME LIKE A FATHER AND GAINED MY TRUST. I STAYED IN CASEY'S TENT ONE NIGHT AND WENT TO HIM FONDLING ME AND HE HAD ORAL SEX WITH ME. I WAS INTIMIDATED BY CASEY AND LET THIS HAPPEN REPEATEDLY, AT TIMES CASEY WOULD TELL ME HOW MUCH HE WISHED I WAS HIS SON AND HOW MUCH HE LOVED ME.

AFTER CAMP WAS OVER CASEY GAINED THE TRUST OF MY PARENTS AND WOULD HAVE ME SPEND THE WEEKENDS CASUALLY WITH HIM. CASEY WOULD OFFER ME ALCOHOL AND GET ME DRUNK. HE WOULD TELL ME HE HAD TAKEN LSD AND SAID HE WOULDN'T EVEN HAVE FLASH BACKS AND HURT ME.

THIS WENT ON FOR 2-3 YEARS, ONLY HIM FONDLING AND GIVING ORAL SEX TO ME. I COULD NEVER BREAK IT OFF BECAUSE HE WAS LIKE A FATHER TO ME AND KNEW I WOULD DO ANYTHING TO PLEASE MY FATHER, YET I DISLIKE THE WHOLE SITUATION. FINALLY CASEY MOVED AWAY AND KEPT WRITING LETTERS.

ONLY IN THE LAST TWO YEARS WAS I ABLE TO TELL THIS TO ~~THE~~ PSYCHIATRISTS WHO I HAD BEEN SEEING FOR 7 YEARS. I FEEL I HAVE SUFFERED OVER THE YEARS BECAUSE THAT CASEY ENJOINED AND WOULD HOPE HE DOES NOT HAVE THE OPPORTUNITY TO DO SO AGAIN. PLEASE CONTACT ME IF YOU HAVE ANY QUESTIONS.

Dear Mr. Baker:

This letter in reference to our phone conversation concerning Mr. Casey Murphree. I met Casey when I was twelve years old (1974) at Camp Orr. I stayed a second week of Camp after my troop left with the Booger Bears (campers without troops). Casey Murphree was the leader. Casey took to me like a father and gained my trust. I stayed in Casey's tent one night and woke to him fondling me and he had oral sex with me. I was intimidated by Casey and let this happen repeatedly. At times Casey would tell me how much he wished I was his son and how much he loved me.

After camp was over Casey gained the trust of my parents and would have me spend the weekends occassionally with him. Casey would offer me liquor and get me drunk. He would tell me he had taken LSD and hoped he wouldn't ever have "flash backs" and hurt me.

This went on for 2-3 years, only him fondling and giving oral sex to me. I could never break it off because he was like a father to me and knew I would do anything to please my father, yet I disliked the whole situation. Finally Casey moved away and kept writing letters.

Only in the last two years was I able to tell this to my psychiatrist, who I had been seeing for 7 years. I feel I have suffered over the abuses of authority that Casey exhibited and would hope he does not have the opportunity to do so again.
