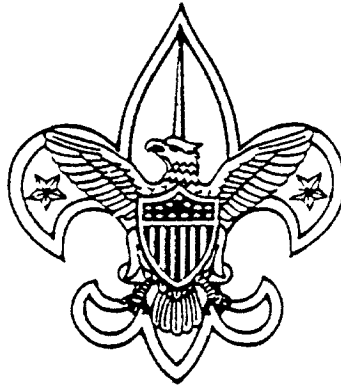

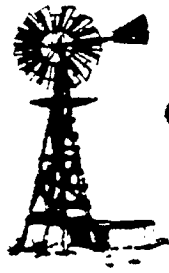
He is currently registered as an Assistant Scoutmaster in Troop 560, District Committee Member of District 605, and an unregistered Scoutmaster of Troop 591.

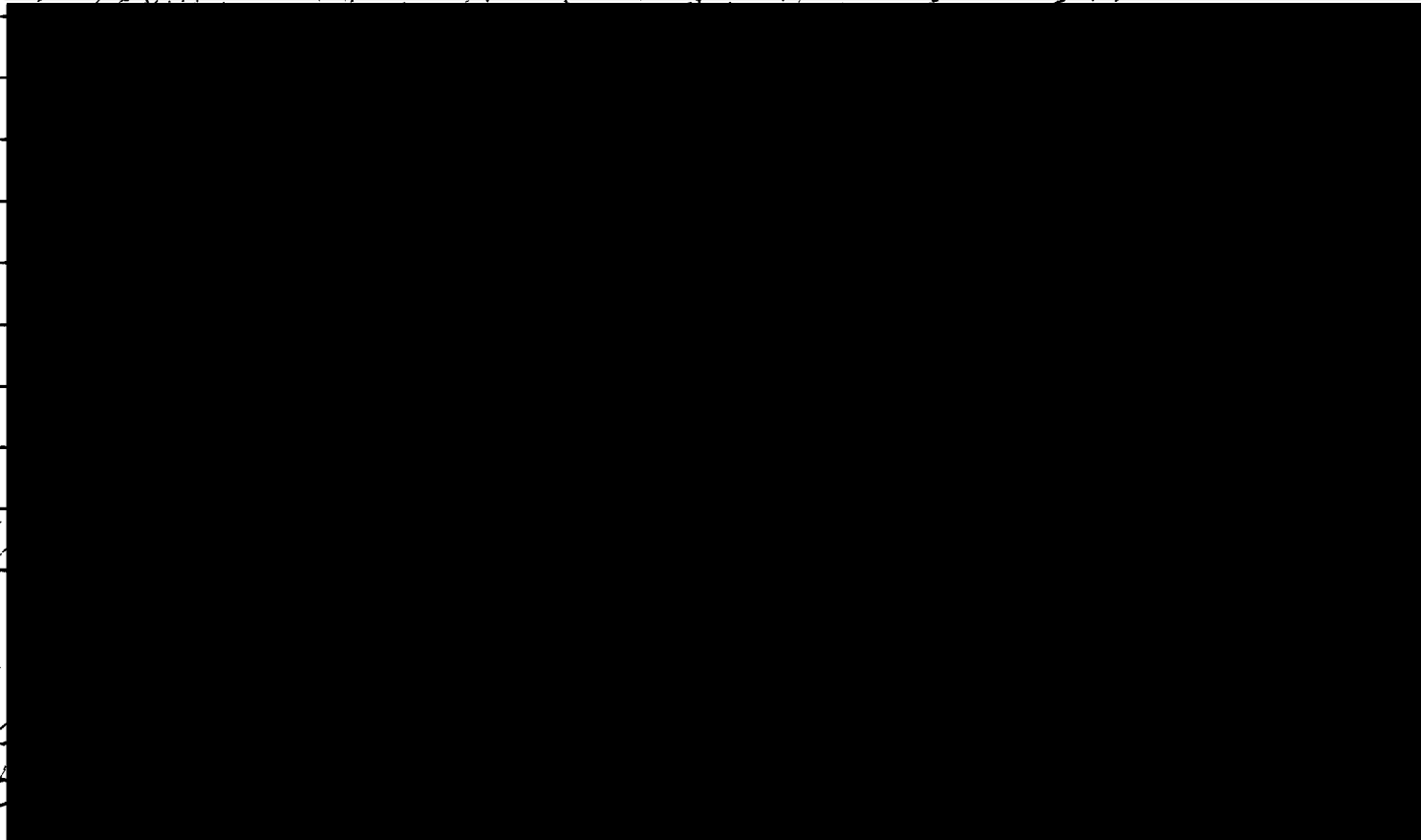
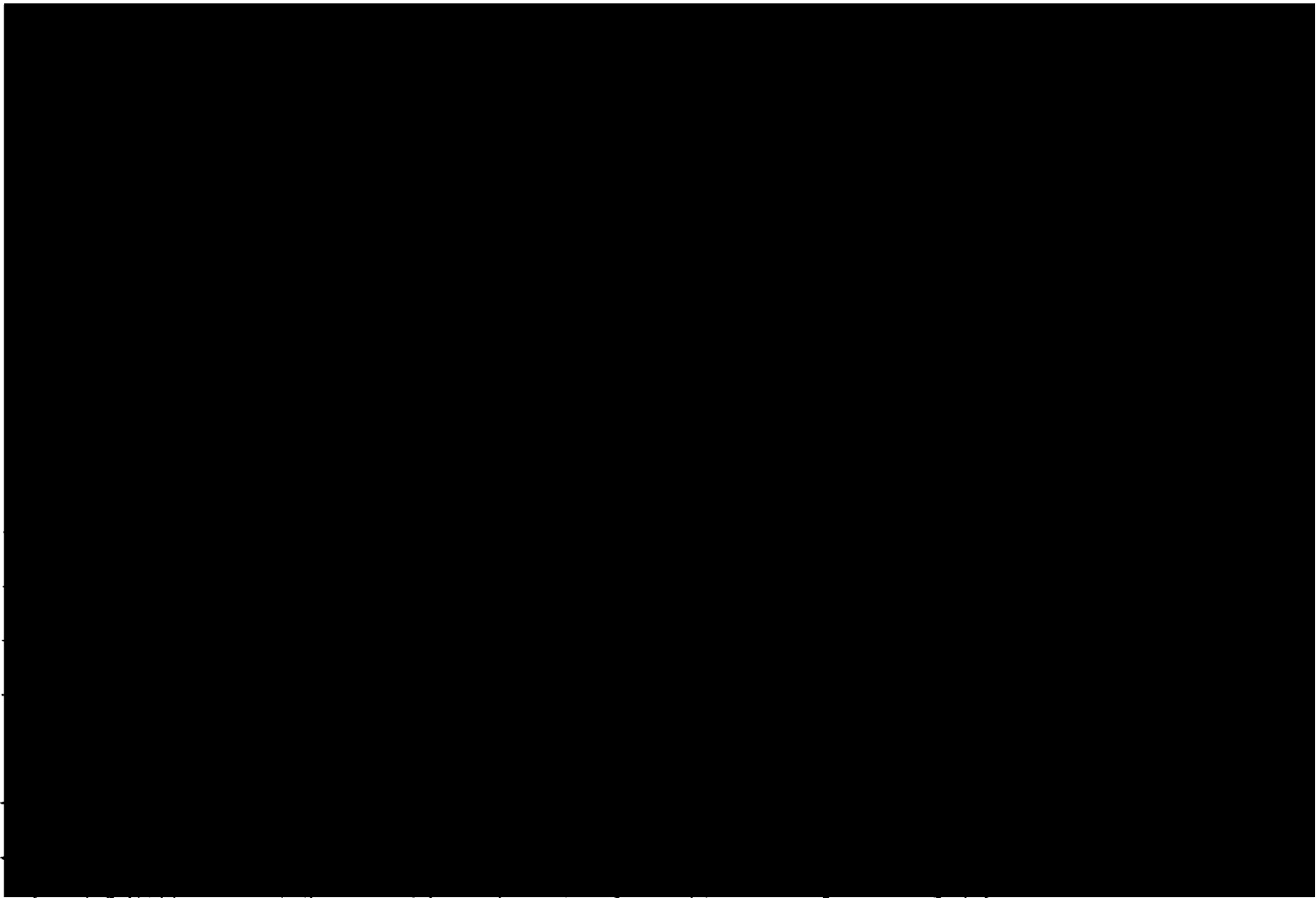

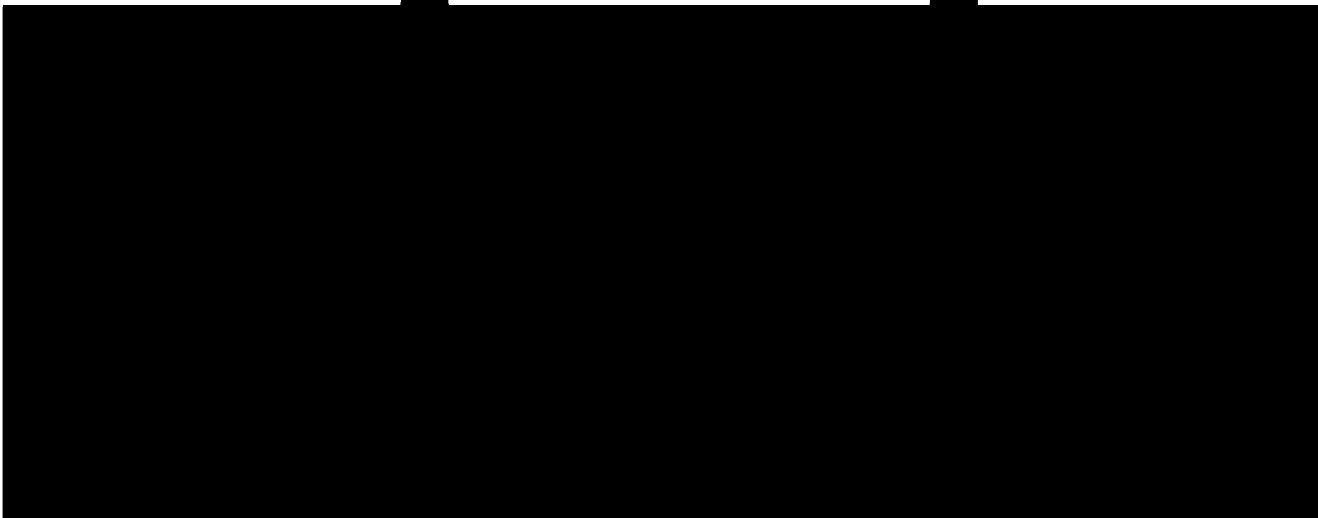

It was around 11:00 A.M. Saturday morning when Chuck asked me some funny questions while the rest of our troop was on a hike. He asked me questions like have I ever had sex before and am I more mature than some of my friends and have my friends or I ever masturbated and questions like that. Well the rest of our troop came back from the hike and I told my friends [redacted] and [redacted] about the questions they had been asking me. They both told me that they thought that was strange.

Nothing else happened the rest of the day until about 10:30 or so when Chuck asked [redacted] and I ~~if~~ if we would like to go to his truck and listen to the radio. We said we would like to so we told [redacted] that we were going to go to his truck.

When we got to his truck he asked me if I wanted a back rub and I said "OK". While he was rubbing my back I was rubbing [redacted] back. Chuck started shaking real hard and ask [redacted] if we wanted to take off our coat because it was warm. We took

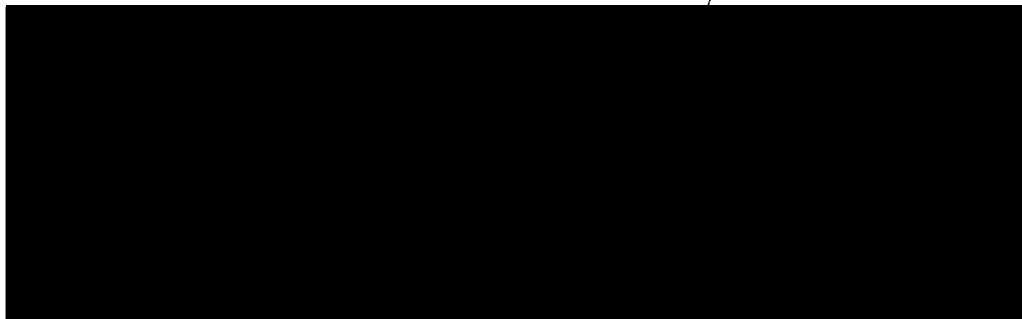

of our coats and started rubbing ~~each~~ <sup>each</sup> others back. Well [redacted] fell asleep + Chuck started rubbing really low down my back. Then he started rubbing my chest muscles and started rubbing my stomach then the upper part of my legs. While ~~he~~ he was rubbing my legs he started moving his hand over and sort of rubbing my private spot. He quit and asked me which felt better this spot, this spot or this spot. I ~~told~~ shrugged my shoulders because I was scared he might do something if I told him I didn't want him to rub me. So around that time [redacted] faked he bumped his head on the car and woke-up! Before [redacted] faked his wake-up Chuck had started \*rubbing my private spot and said "do you like that" and I said "yes" because I was so scared. Then he said "I know why you like this place for me too rub because of this" + put his finger down on my private spot + then said "you're horny" + sort of chuckled. Anyway when [redacted] woke-up he started to leave and left. Chuck asked me too stay but I made an excuse up + left. A hot night we thought we saw him walking around our tent all night. Nothing else happened the rest of the camp-out.

But at no time did I left the Camp  
that night, early we went hiking and I  
took all the boys next to [redacted] and Chuck!  
For about 1 hr. But nothing happened then because  
there were 3 troops camp by us and boys were  
running all over the place, and Chuck had  
locked his key in the pickup and was trying  
to open it to the best of his ability with out  
having to break the window;

and that in the full extent of our  
camping trip all just for some minor details  
we arrived here at St John Newman church  
at 1.15 PM



## STATEMENT

Scoutmaster

March 2, 1987

I am [redacted] Scoutmaster for Troop 591. When on a camp out Feb. 28, 87 to March 1, 87 and while there on Saturday morning the Chuck Bredwin my ass scoutmaster took the boys camping.

Saturday morning all is well till about 9 o'clock when [redacted] and [redacted] came to me and said that some one from troop 528 had try to play with him. and so I talked to them what was the difference between an sex molestation and a friendly hug and sat on the back and then the rest of the day [redacted] stay [redacted] and [redacted] were very uncooperative.

then about 6.30 pm we ate supper and [redacted] wanted to play capture the flag with the boys of 114 at 10.30 pm to 11.30 pm. so they played the game. when the game was over I went to my tent to read my Bible and daily prayer and church and [redacted] went to church pickup, and were gone for about 30 min. at the meet. He came in church and we talked a little bit, then we went to bed.

Next morning the three boys [redacted] were late getting up so I went and talk to [redacted] at what time he told me that he had diarrhea last night, so I told him that he could go and rest then. But [redacted] and [redacted] just did not want to take part in any thing at all. But at any time did [redacted] a boy told me any thing that had happened. I did not heard any thing about it until [redacted] call me and told me about the hold thing.

## STATEMENT

Chuck Beaudoin Assistant Scoutmaster

March 2, 1987

I assume the approximate time to start would be after the camp fire which ended about 10:30-10:45pm Feb 28. At that time I explained the rules to a game the the scouts of Troop 591 and Troop 114 had challenged each other in. The game progressed for about an hour, at which time I ended the game. At that time [redacted] said he was going to the tents. I then told him that I was going to the truck to warm up and asked [redacted] and [redacted] to come over if they wanted to. "I wanted to talk to them." In a few minutes they came over and entered the truck. We talked for a few minutes, the [redacted] complained that his legs and neck were sore. Prior to this I had told them to pull their coats off so that when they left it would not be as cold. They agreed.

I then said to [redacted] that if he was sore, I would rub his shoulders and legs if he wanted me to. He agreed. I then proceeded to rub his <sup>Arms, upper torso</sup> shoulders, ~~arms, legs~~, and legs. Which at the time he appeared to enjoy from the grunting sounds he was making. [redacted] then said if you're enjoying it that much he told [redacted] to rub his shoulders. In a few moments either [redacted] or myself made the comment this seems a bit odd and we all agreed. I then told them if it felt so good [redacted] to rub my shoulder, and he did, I would guess probably for about 2 minutes. I then went around and rubbed [redacted] shoulders a bit more. At some time during this [redacted] if he wish he was lying on a table, odd I thought but didn't pay any attention. I then asked him where it felt best. He said anywhere. So I just rubbed his legs and back some more. About this time [redacted] closed off and hid his head →

to bed, and get out and shut the door. Just after he shut  
the door I asked Alvin did he enjoy that and he said yes but  
he wanted to go with [redacted] and [redacted] because they were  
going to do something. I said alright good night, he then  
got out and slammed the door. Which I immediately began  
wondering I had done anything wrong. I could not think  
of anything at the moment so I didn't give it another thought  
and looked up and went to the tent that [redacted] and I  
~~where~~ were staying in, when I got into the tent I noticed  
that he was awake. I then got in bed and fell asleep.

Next morning I awake and got dressed, and over heard [redacted]  
holding a small Bible class. I took the tent and went to the fire  
like everybody does in the morning. I asked [redacted] what was for breakfast  
and he said Bacon and eggs at that time he was frying the bacon.  
I said ok. I then cooked the eggs for breakfast but the  
senior patrol leader and one of the patrol leaders that were supposed  
to eat with us were not out of bed. [redacted] then told them to  
get out of bed and that they should not sleep late but should  
be <sup>and</sup> up about their responsibilities. They ignored him. We went  
ahead and ate breakfast and I cleaned up the dishes.  
then held a small Charles Service for the troop. But [redacted]  
[redacted] and [redacted] did not leave their tent. [redacted] said the  
had said something derogatory to him. After the services I  
went over and asked why they were not up. [redacted] then  
said that he was sick to his stomach because of supper  
last night and had made a mess in his pants. I  
said that they need to get up and then left. As I was  
cleaning up I called [redacted] out of his tent and gave  
him some Pepto Bismol tablets and said see if these help.  
He took them and later said they helped. When the Troop  
was just about packed the other three began taking down  
their tent and packed. we then had them ~~put~~ clean the  
area of trash. And got ready to leave.

March 2, 1987

At this time [redacted] and [redacted] began getting into the vehicles, and [redacted] immediately got into <sup>the</sup> back seat of my truck and two others in the front seat. I said good bye to some people at camp and left for Post where the troop stopped to get a snack. [redacted] and [redacted] stayed in the truck. The trip back was uneventful, we arrived at the church and all these [redacted] disappeared. [redacted] showed up a few minutes later at that time I scolded [redacted] for not listening to me earlier and staying until the vehicles were unloaded. I then told him to do some push ups at which time I did. Shortly thereafter I asked [redacted] if I could leave I had home work to do, he said ok and I left.

The above is correct as much as possible without verbally explaining. The only thing else I could think that might be of importance is earlier Saturday morning [redacted] had said an old man had put his arm around him and had rubbed his stomach which surprised [redacted] when I found out who it was I explained that he was friendly and that was his way of greeting people which seemed to reassure him somewhat. Anything else I would consider unimportant.

3/2/87

On February 28, Saturday, around noon we as a troop were going to hike through camp to show the new kids the camp. As we were leaving Chuck and [redacted] were going to stay behind and eat lunch because they were working with [redacted] in [redacted] tent, they said they would finish and then meet us near old baldy. I would say about 2 hours passed and neither [redacted] showed up to meet us. When we returned, [redacted] immediately told me Chuck had purposely locked his keys in his truck to ask [redacted] questions about his sexual practices and other personal matters and preferences. [redacted] also told me that Chuck told him about his practices when he was a teenager. Later after they recovered his keys me [redacted] and a few other boys were standing in camp talking about the capture the flag game. Later that night Chuck walked up and asked [redacted] if he was telling anyone about what they were talking about. Chuck repeated that question at one other time that day. After the capture the flag game I heard Chuck invite [redacted] to go into his truck. A few minutes later Chuck also invited me also, probably because I had heard the initial question. About 15 minutes later me and [redacted] were walking toward the truck and then got in. Chuck said to take off our jackets and get comfortable. Chuck then asked [redacted] if he wanted his back rubbed and [redacted] said ok. A few [redacted] later I asked [redacted] to rub my shoulders and neck because I had



neck cramps. [redacted] did for a few minutes and stopped, I was very tired and fell asleep. A few moments later [redacted] started tapping me on my back in a way as if to get my attention. I heard some strange noises and heard chuck say asking "where does it feel better, how does this feel, pick a place and tell me when I touch it. I was then pretending to be still asleep I heard them moving around and heard chuck tell [redacted] to get his foot off of the brake pedal. Then chuck asked again to pick where it felt better and he asked [redacted] if he wanted him stop. [redacted] tried to tell him he wanted him to stop. I then pretended to fall over and hit my head. when I got up and said I was going to go to my tent and go to sleep, when I was getting up to leave I saw chuck leaning against his door and he had his arms around [redacted]. I left using my flashlight in a careless manner so if chuck was watching he would know I was going to my tent. I was going to my tent to get my hunting knife and sneak ~~back~~ back in case chuck would not stop and I might need it to defend myself and [redacted]. Just as I arrived to the tent and got ~~in~~ in [redacted] arrive and was crying. He told me what was happening even though I knew. [redacted] who was also in our tent - knew something was wrong but we couldn't talk because someone who we all thought was chuck was sneaking around our camp all night. [redacted] and [redacted] switched places so [redacted] would be closer to me for protection, we hardly got any sleep all night. The next morning [redacted] and me all ~~got~~ slept late or actually stayed in our tent very late, [redacted] got up because he had to cook for his patrol, chuck then came back from somewhere and was sneaking up on me and [redacted] I heard his footsteps and saw him through the tent. I motioned to [redacted] and we changed our conversation. [redacted] saw chuck sneaking up and yelled at us to pack his stuff and started walking up the trail. Chuck was at the [redacted] he was there to tell us [redacted]
