

I spoke to May Pleer today and she informed me that Mr. Charles Rileigh was never placed on file with national. Please note the following information that I obtained from the Middlesex County Clerk of Courts.

Charles E. Rileigh, Arlington pleaded guilty in Middlesex Superior Court to 15 counts of "Contributing to the delinquency of a minor" on 12/30/80. Docket # 80-2727 placed on file the same date by Judge Linscott.

On 12/30/80 Mr. Rileigh was charged with 15 counts of carnal abuse, docket # 80-2728. He pleaded guilty to three counts and was sentenced to 2.5 to 3 years at Walpole State Prison. Remaining counts placed on file by Judge Linscott.

Mr. Rileigh was born on 9/22/44. No other information is available at the present time.
