



Dear Ben:

I have discovered a very distressing fact today, and I must pass it along. There is a man in Lone Star, Texas, that was picked up last night on a morals charge. Photographs in his possession indicate numerous acts of his being involved with relatively young boys. And, many of these pictures were taken with a "Boy's Life" prominently displayed in the background.

This man's name is Charles Edward Johnson. He moved to Lone Star from Dallas where he was reportedly a Cub Master and Scoutmaster. I would appreciate your checking to see if he is on the black list, and, if he is not, please put him on the list immediately.

He is presently living in Lone Star with four or five "adopted" young boys. The Welfare Department is presently in the process of removing them from his custody.
