Scout leader gets 4 years for molesting boy

AN ASSISTANT scontmaster was senlenced to four years in prison Wednesday for sexually molesting an 11-yearold boy during a campout with his, troop at Camp Thunderbird in Du Peze

Judge J.J. Bowman of Du Page County Circuit Court, in sentencing Charles go, recommended that he be placed in an institution where be can receive psychiatric counseling.

Before passing sentence and denying probation. Judge Bowman noted that Fugate had been placed under court supervision for a sex crime in 1974.

"You received psychiatric counseling for only one month and were back in court within three years charged with a similar crime," Bowman told Fugate.

"I SELIEVE there is a pronounced ty Circuit Court, in sentencing charies
Fugate, 23, of 2510 S. Homan Av., Chica-, threat to the public if you are placed on probation."

Bowman added that the need for psychiatric counseling was obvious and thatalthough he had considered many factors-including Fugate's age and schooling-"these are outweighed by the fact that the state did give you a previous chance." referring to the 1974 case in which Fugate was charged with-contributing to the delinquency of a minor.

In denying a request by Fugate's attorney for a new trial, Bowman said the corroborating evidence was not only testimony of the victim but Fugate's confession to police.

Four witnesses, including Fugate's

aunt and grandmother, who raised him testified in his favor at the sentencing and said he had been a babysitter with small children of friends and relatives with no problems, and that he could be trusted to do so again if he were granted probation.

THE WITNESSES included two neighbors with small children or grandchil-

Fugate was convicted in a bench tria! before Bowman on Scpt. 21. The defense presented no case during the trial.

Scout worker guilty of molesting boy, 11

AN ASSISTANT scoutmaster was found guilty Wednesday of sexually molesting en 11-year-old boy during a campout with his troop at Camp Thunderbird in south Du Page County.

The verdict was handed down against Charles Fugate, 23, of 2510 S. Homan Av. Chicago, by Du Page County Circuit Judge J. J. Bowman.

Before the verdict was announced by the judge, Fugate's attorney, Don Wilkinson, had attacked the youth's testimony Tuesday in the bench trial as "contradictory" and termed it "incredible."

But Judge Bowman said: "Because of the nature of the case, it is understandable why he [the boy] testified the way he did. It is

my opinion that the boy was truthful."

THE DEFENSE presented no case during the trial.

Judge Bowman set sentencing for Oct. 12. Law enforcement officials said that if Fugate is not given probation, he must receive a minimum of four years in prison.

The verdict came after testimony Wednesday by a Du. Page County detective that Fugate, on June 14 after his arrest, told him he had committed a sex act on the 11-year-old boy.

The defective, Peter J. Tanke, of the Du Page county sheriff's police, said Fugate admitted to him that the sex act occurred in a tent at the camp. The detective added that Fugate also disclosed that another boy was asleep in the tent at the time.

Under questioning by Assistant State's

Atty. Frank De Salvo, the detective said Fugate told him that during the camping period other incidents with sexual overtones had occurred.

Tanke said Fugate told him that in one instance, the 11-year-old boy was brought into Fugate's tent and shown pornographic comic books.

THE NAME of the troop's scoutmaster, Patrick Weglarz, 26, of 4410 Kingston St., Lisle, was brought in during Tanke's testimony.

The detective said Fugate had told him that he and Weglarz took the 11-year-old boy on a hike during the encampment, purportedly to help the boy win a merit badge, but in fact with the idea of performing a sexual act with him.

Weglarz, who also has been charged in the case, is to be tried separately.
