



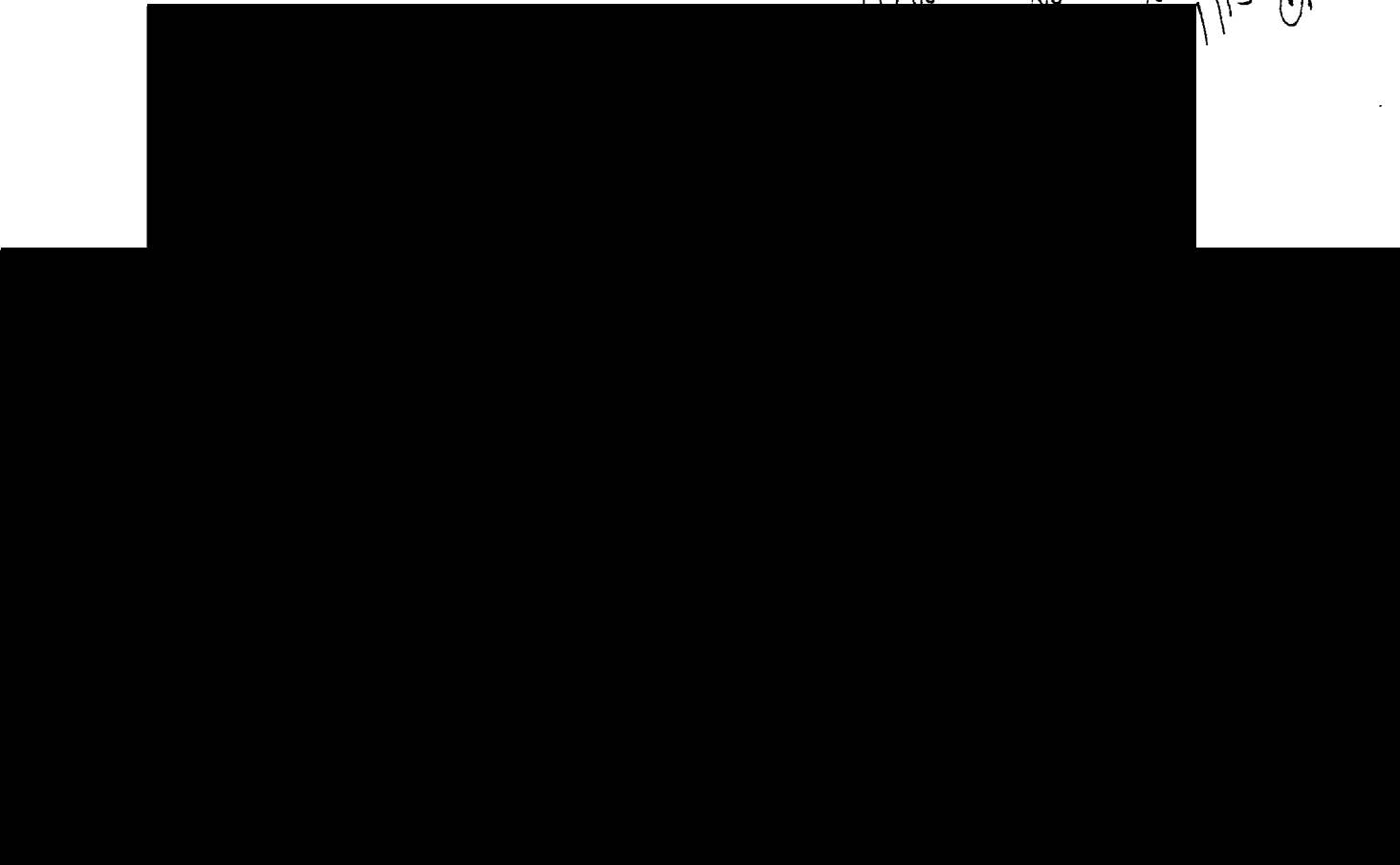

Dear Mr. Corrie:

I have been instructed by Debra Duhs of the National Council, Boy Scouts of America, to send copies of the enclosed material to you. We have not been formally served with notice of this suit and at this stage only know what is included in the news story.

We were aware of the incident when it occurred and the offender, Charles Herring, was registered as an Assistant Scoutmaster at the time. He was arrested, tried and convicted and sentenced to 2½ years in the state penitentiary and 2½ years probation. His registration was cancelled by the local council on the date of the offense and he was also notified by the leadership of Troop 3 that he was no longer registered with the troop.

The boy involved was not a registered Scout although he had visited a troop meeting. The activity where the offense occurred was not a Scout activity but an outing involving the offender and two boys. The act involved soliciting by the man and a contact by hand only. As far as we have been able to determine, this is the first record of an offense.

I met last evening with the pastor of First Lutheran Church and about 12 members of their Troop Committee. I was accompanied by Reuben Davis, Council Vice President for Camping and also an active Scoutmaster and an attorney. Purpose of the meeting was to discuss liability coverage, possible contacts that will be made by press and/or attorneys or investigators. We requested that statements be limited to acknowledging that they knew Mr. Herring when he was involved with the program but that they refer any callers to Herb McCoggins at the local Boy Scout office.

I was instructed by Debra Duhs to ask you to contact her before assigning an attorney to this case.

Teachers to Get Pay Hike in Late May

Some reached between \$17 million and \$18.1 million. The district has an actual income to date of \$15.2 million, said Superintendent Don Irvin. Projections are for income to reach nearly \$18 million by the end of the fiscal year on June 30.

"The board felt safe that they could go ahead and grant the raises at this time," Irvin said. "They felt the projections would come in. And more than likely, they'll be here by the end of the fiscal year."

The board voted 4-1 for the raises Monday, with board president Larry Miller voting against

the move. Board member Jim Bradshaw was absent.

The pay raises will cost the district \$265,000, Irvin said.

Raises will go to all but the district's 34 first-year teachers, he said. The other 422 teachers will get raises averaging \$589 each, representing one step up on the district's pay scale.

Death Penalty Sought in

World Washington Bureau
WASHINGTON — Oklahoma officials Tuesday asked the Supreme Court to reinstate the death penalty for a Muskogean man who killed his former boss and slashed the throat of the murder victim's wife.

The death penalty given to William Thomas Cartwright was vacated by the 10th U.S. Circuit Court of Appeals at Denver on grounds that the victim wasn't tortured prior to the slaying in a "heinous" manner.

He is now serving a life sentence.

Prosecutors said Hugh Riddle was shot and killed from close range in 1982 after his wife discovered Cartwright in their Muskogee home.

Cartwright, the Supreme Court was told, shot Mrs. Riddle in both legs when she confronted him in a bathroom hallway in the home.

Cartwright then went to the living room where he killed Riddle with one blast from a shotgun, the court was told.

He then went to a bedroom where Mrs. Riddle was attempt-

Boy Scouts, Church Hit By \$1.5 Million Lawsuit

The mother of a 13-year-old Tulsa boy filed a \$1.5 million suit Tuesday alleging a Boy Scouts leader made lewd advances toward her son on a 1987 outing.

Charles Francis Herring, 40, pleaded guilty May 22 to a charge of molesting the boy. He was sentenced July 23 to 2½ years in prison plus 2½ years of probation.

Named as defendants in the Tulsa District Court civil lawsuit are Herring, the Boy Scouts of America, and the First Lutheran Church of Tulsa, sponsor of the boy's troop.

The suit claims Herring made improper advances and placed his

hands on the boy while giving him a ride home from an outing.

The suit alleges the Boy Scouts of America and the church negligently put Herring in a position of trust as a troop leader.

In the criminal case, Herring was accused of offering the boy \$20 to perform a sex act while they were alone at Turkey Mountain park on April 21, 1987. The boy refused, police said.

The boy said Herring fondled him inside a truck later that day, a Department of Corrections sentencing report said.

Herring, of Tulsa, claimed he was an assistant scoutmaster and met the boy a week before through scouting, the report said.

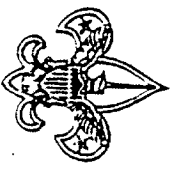

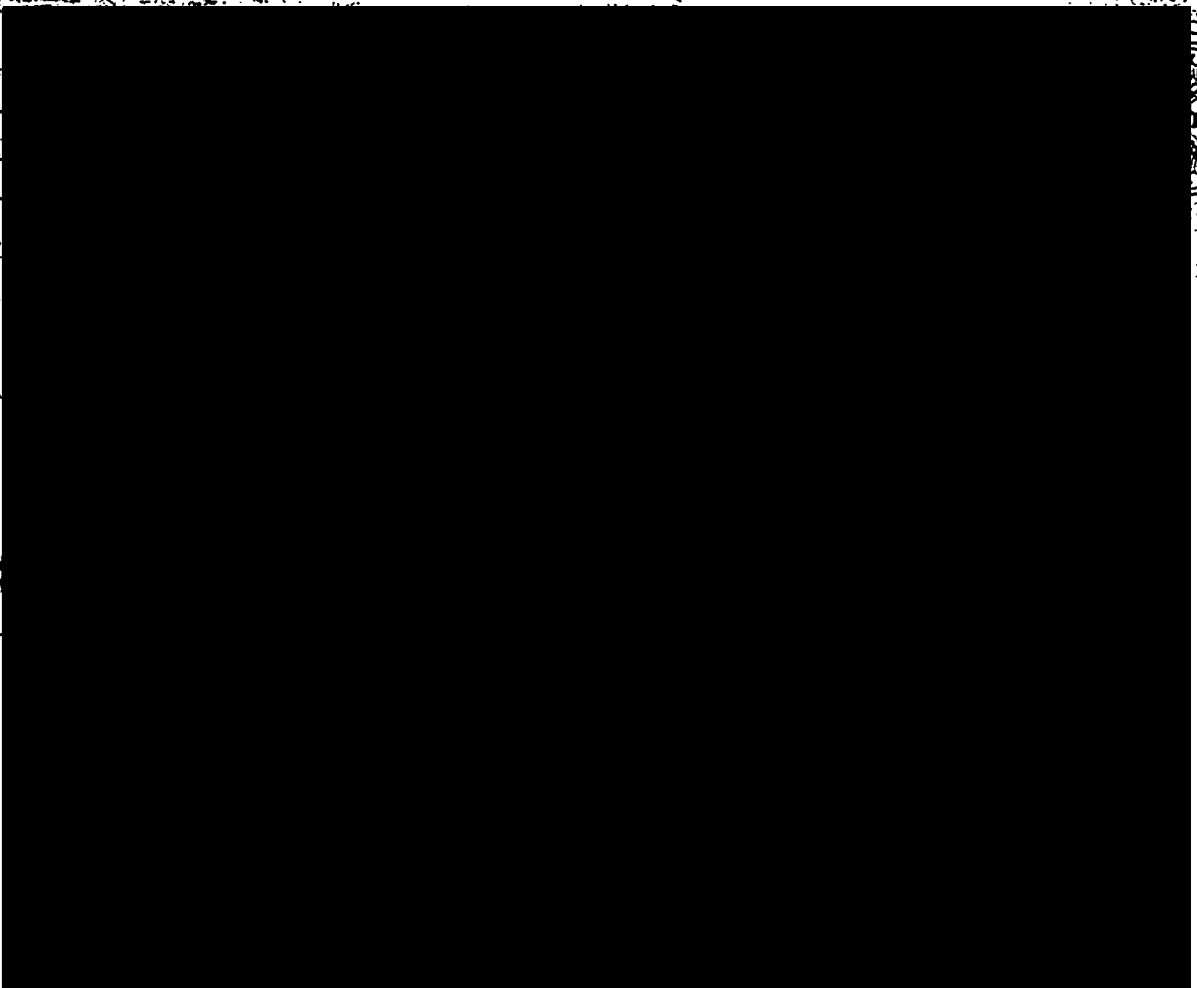
