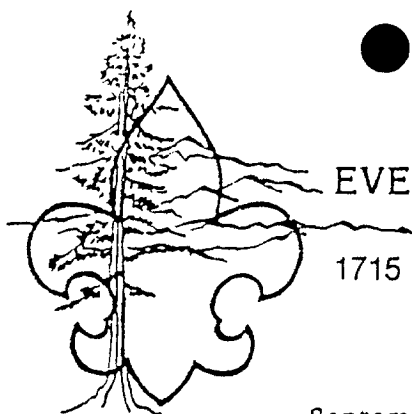

Enclosed are two separate pieces of information. The newspaper article relates to Charles S. Grewe, who has a registration denial file at the National Office beginning in March 1988. This is updated information.

The second enclosure is the letter and background information on the denial of registration of Richard Osher. I thought you had been given copies of the information in August when this action was taken by our Field Director, Bruce Spencer and Council President, Bob Overstreet. I was on vacation at the time.

Richard Osher had been serving as our Council Commissioner up to a month prior to when Bruce Spencer received a phone call from Terri Clark [REDACTED] at the Department of Social and Human Services (DSHS). She told him that Osher was being investigated for the molestation of [REDACTED], [REDACTED] who is in her mid-teens.

[REDACTED] was supposedly molested as a young child by someone else and has been undergoing therapy for several years. While in therapy sessions these past months, she has repeatedly claimed that Osher had molested her. We have no verification that this charge has been proven true; however, DSHS asked him to inform us of this situation.

Spencer and Overstreet met personally with Richard and his [REDACTED] when they handed them the letter suspending his registration. The [REDACTED] knowing BSA standards and procedures, expected this action. They expressed the feeling that it had to be done.


At this time Richard and [REDACTED] feel he is innocent. They claim that he has taken a lie detector test which has proven that he did not molest his [REDACTED]. [REDACTED] also feels Richard has been extremely supportive in trying to help [REDACTED] seek help through counseling over the years.

At this time the allegation against Richard Osher has not been resolved one way or another. His registration is suspended.

# 5-year term for child molesting overturned by state appeals court

SEATTLE — The Washington State Court of Appeals Monday overturned an exceptional five-year prison term for a Snohomish County school bus driver convicted of sexual offenses.

A unanimous three-judge appeals panel ruled that Snohomish County Superior Court Judge Richard J. Thorpe wrongly considered incidents for which no charges had been filed when he sentenced Charles S. Grewe last year. The panel also said Thorpe

relied partly on factors that had been taken into account in the standard sentencing range.

The appeals ruling sent the case back to Superior Court for resentencing.

A jury found Grewe innocent of two counts of indecent liberties but convicted him of two other counts of indecent liberties and one count of attempted first-degree statutory rape.

Three students testified that Grewe touched or attempted to touch

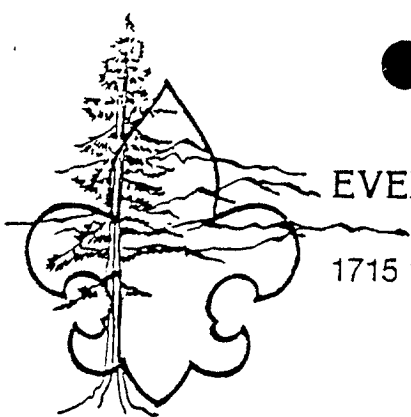
their "lower private parts," all in 1988.

The standard sentencing range for the convictions was 30 1/4 to 40 1/2 months, or about 2 1/2 to less than 3 1/2 years.

Before passing sentence, Thorpe heard from one witness who said Grewe touched his genital area at a Boy Scout camp in 1981, when Grewe was an assistant troop leader; another who had a similar experience when Grewe was his school bus driver in 1987 and a third who said Grewe exposed himself at the Five Mountain Boy Scout Camp in 1987.

The appeals verdict said the statutory rape conviction involved abuse of a position of trust.

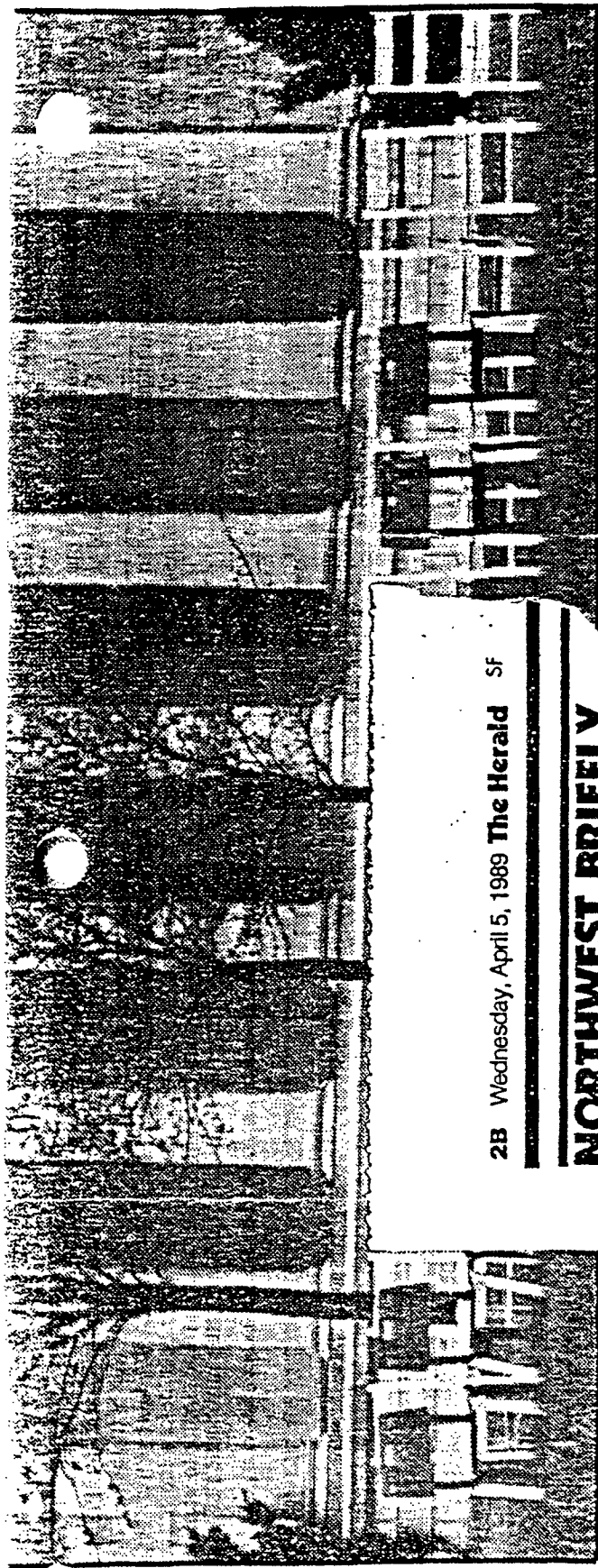

# Child molester gets tougher 5-year sentence

A former Everett school bus driver convicted of sexual misconduct with minors received a stiffer sentence Tuesday than the state-recommended punishment for his crimes.

Charles S. Grewe was sentenced to five years in prison for one count of attempted first-degree statutory rape and two counts of taking indecent liberties with children.

In February, a Snohomish County jury delivered the guilty verdicts and acquitted Grewe, 31, on two other indecent-liberties charges.

Under state sentencing guidelines, Grewe faced a maximum penalty of three years and four months in prison.

But Snohomish County deputy prosecutor Diane Hess Taylor argued Tuesday for the exceptional

sentence, saying Grewe was dangerous because he'd sought out his victims in a predatory manner and hasn't shown he's amenable to treatment.

Grewe abused his position of authority over children, she said, and has "gone to great lengths to convince people these children are lying."

Taylor called a 22-year-old man and 16-year-old youth to testify Tuesday about incidents in which they alleged Grewe touched them improperly. The 22-year-old said his run-in with Grewe occurred nine years ago when he was in the Boy Scouts and Grewe was his scoutmaster.

Defense attorney Michael Clarke emphasized Grewe has not been charged with any crimes stemming from his involvement with either of these people.

He said most of the charges against Grewe involve only touching.

"There's only one incident where Mr. Grewe has gone beyond brief touching outside the clothing," Clarke said.

Superior Court Judge Richard Thorpe said Tuesday's testimony is "part and parcel" of what he heard during Grewe's trial.

The judge will recommend Grewe receive treatment at the state's new sexual offender program at the Twin Rivers correctional facility in Monroe.

"I'm not sure 60 months is going to be enough, but I hope and pray you make good use of those facilities," he told Grewe.

Two of the charges against Grewe stemmed from incidents that occurred on Grewe's school bus, prosecutors said, while the others involved children in Grewe's neighborhood.

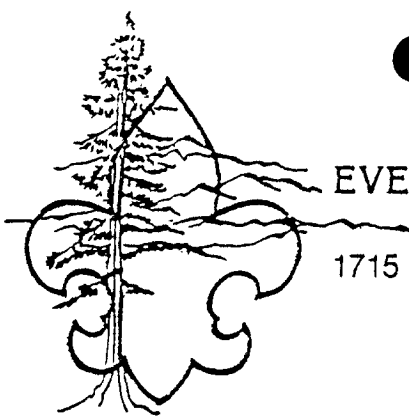



EVERETT - A Snohomish County Superior Court jury convicted a former Everett school-bus driver of three counts of sexual misconduct involving minors but found him innocent of two counts of taking indecent liberties with children.

Two of the counts stemmed from incidents that prosecutors said occurred on the school bus, while the others involved children in Grewe's neighborhood.

The defense maintained that any inappropriate touching that occurred on the bus was not done intentionally. The prosecution argued that all four children who testified said they knew there was something wrong about the way Grewe touched them.

# Bus driver convicted on 3 of 5 sex counts

The Snohomish County Superior Court jury deliberated for only an hour Thursday and part of Friday before delivering its verdict on Charles S. Grewe.

Grewe was charged with four counts of indecent liberties and one count of attempted first-degree statutory rape. The jury issued a guilty verdict on the statutory rape charge.

Two of the counts stemmed from incidents that prosecutors said occurred on Grewe's school bus, while the others involve children in Grewe's neighborhood.

Grewe drove a bus for Durham Transportation of Washington Inc., which worked under contract for the Everett School District.

Defense attorney Mike Clark said in closing arguments Thursday that any inappropriate touching that occurred on the bus was not done intentionally or for the purposes of sexual gratification.

# Jury deliberates in sexual-misconduct trial

Children who testified earlier this week against a former Everett school bus driver knew there was something wrong about the way the man touched them, a Snohomish County deputy prosecutor said Thursday.

Diane Hess Taylor said in closing arguments that Charles S. Grewe, who has been on trial for five counts of sexual misconduct involving minors, mistakenly thought that children are "very tolerant" of inappropriate touching.

"Children are playful by nature, they tolerate more touching than adults," Taylor said. "But all of the children knew there was something funny about the way Mr. Grewe touched them."

Grewe's trial began Tuesday and ended Thursday afternoon. The jury deliberated for an hour and reconvened this morning.

Grewe is charged with four counts of indecent liberties and one count of attempted first-degree statutory rape.

Two of the counts stem from incidents that allegedly occurred on Grewe's school bus last spring, while the others involve children in Grewe's neighborhood. A 6-year-old boy, 9-year-old girl and two 12-year-old girls testified this week.

Defense attorney Mike Clark argued that the children's testimony contained inconsistencies and that any touching on Grewe's part wasn't intended to be sexual.

If any inappropriate touching occurred with the two older girls on the bus, he said, it was "not done knowingly or for sexual gratification."

Clark said testimony from the two neighborhood children was inconsistent about when and where the alleged sexual misconduct occurred.

The boy testified Tuesday that Grewe touched

him on his "private" while the two of them were sitting in a rocking chair in Grewe's house. Clark asked the boy if he remembered saying in pre-trial interviews that Grewe touched him when they were on a couch.

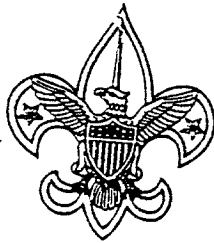
The boy said he didn't remember saying that.

Clark noted that the boy couldn't remember when the incident occurred. The girl's story, he said, was unclear about where she was in Grewe's house when Grewe allegedly had sexual contact with her.

Taylor said discrepancies in the children's stories are "a fact of life."

But, she added, there's no reason to believe the children are lying.

"There's always the danger in a trial setting of these kinds of incidents sounding sterile," Taylor said. "It may not sound like a very big deal. Please try to avoid that pitfall. Please try to think what these children must have gone through."

# Boy testifies in former bus driver's trial

A 6-year-old boy testified Tuesday that a former Everett school bus driver touched his "private" after inviting the boy into his house and serving him cocoa.

The boy was the first of four children to take the stand in the Snohomish County Superior Court trial of Charles S. Grewe, 31, is charged with four counts of indecent liberties and one count of attempted first-degree statutory rape.

Two of the charges stem from incidents that allegedly occurred on Grewe's school bus last spring, while the others involve children in Grewe's neighborhood.

A 9-year-old girl and two 12-year-old girls will testify this week.

In Tuesday's testimony, the boy told deputy prosecutor Diane Hless Taylor he often visited Grewe to play with his dog.

Only once, he said, did Grewe invite him inside. The boy said he played with a coloring book and Grewe served him cocoa. Then, he said, Grewe had him sit on the man's lap in a rocking chair.

"He rubbed my private," he said, adding that Grewe touched him on top of his clothes.

The boy said Grewe gave him a lollipop before he went home. He said although the incident made him feel "not fine," he didn't tell anyone about it until much later because he feared punishment.

Defense attorney Mike Clark asked the boy if he remembered saying in pre-trial interviews that Grewe touched him when they were sitting on a couch, not a rocking chair.

The boy said he didn't remember saying that.

He told Clark that he'd gone to

counseling because a baby sitter had touched him inappropriately in the past.

"Do you remember getting in trouble at counseling for telling lies?" Clark asked.

"Yes," the boy said, adding after further questioning that he rarely got into trouble for lying.

In his opening statement Tuesday, Clark told jurors to expect discrepancies in the children's stories and to listen carefully to testimony because Grewe's playful gestures may have been mistaken for sexual touching.

"You will hear all the children say they liked Mr. Grewe, they liked to wrestle with him," he said.

He said Grewe, in turn, likes children and has been active with the Boy Scouts and other youth organizations. Grewe was a driver for Durham Transportation of Washington Inc., which works under contract for the Everett School District.

# School bus driver faces additional sex charges

A former Everett school bus driver already facing allegations he molested two neighborhood children was charged Wednesday with taking indecent liberties with two more children on his school bus.

The new charges conclude what prosecutors had described as a "major child sexual abuse investigation" into the activities of Charles S. Grewe, 30, of Everett.

When Grewe was first charged in June, prosecutors said they were looking into complaints filed by a half-dozen Silver Lake Elementary School fifth-graders who alleged Grewe molested them on his bus.

Wednesday's Snohomish County Superior Court charges allege Grewe took indecent liberties with two young girls in incidents between March and May, according to deputy prosecutor Diane Hess. The court papers provide few other details of the investigation, however.

Grewe drove a bus for Durham Transportation of Washington Inc., which worked under contract for the Everett School District. A company

spokesman said after the initial charges were filed that Grewe was no longer driving a bus for the firm.

No trial date has been set on the new allegations.

Grewe is still awaiting trial on the earlier, unrelated charges that he took indecent liberties with two neighborhood children. He had pleaded innocent to the allegations.

An 8-year-old neighbor girl told investigators that Grewe molested her on two occasions since last Christmas when she visited his home, deputy prosecutor Michael Downes said.

A 10-year-old girl witnessed one of the alleged incidents, telling sheriff's detectives she saw Grewe touching the younger girl "all over," the prosecutor said.

A 6-year-old neighbor also told a sheriff's interviewer that Grewe once offered him a lollipop and cocoa and asked to touch the boy's private areas, the prosecutor said.

Prosecutor Downes said Grewe also has been actively involved in Boy Scout activities and outings, but the charges are unrelated to those activities.



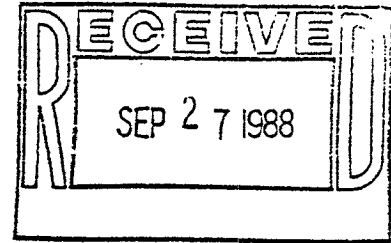

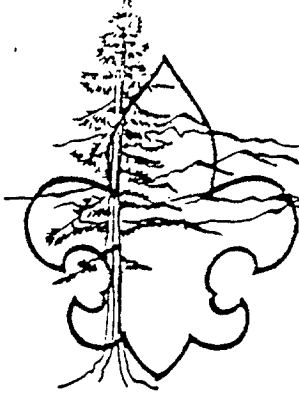

# Driver of school bus probed in sex abuse

A 30-year-old Everett school bus driver is the target of "a major child sexual abuse investigation" involving complaints by at least a half-dozen fifth-graders who say he molested them on his bus, prosecutors said Tuesday.

Charles S. Grewe of Everett was charged Tuesday in Snohomish County Superior Court with two unrelated counts of taking innocent liberties with two neighborhood children.

Grewe is being held on \$25,000 bail and was scheduled to be arraigned today.

He drove a bus for Durham Transportation of Washington Inc., which worked under contract for the Everett School District. A company spokeswoman said Grewe was no longer driving a bus but declined further comment.

According to deputy prosecutor Micnae Downes, Grewe also has been actively involved in boy Scout activities and outings.

Snohomish County sheriff's investigators referred one case to Skagit County authorities involving acts allegedly committed with a youth at a Scout camp in that county, according to the court papers.

Grewe was charged Tuesday with taking innocent liberties with an 8-year-old neighbor girl. The Everett girl told investigators that Grewe molested her on two occasions since last Christmas when she was visiting her home, Downes said.

A 10-year-old girl witnessed one of the alleged incidents, telling sheriff's officers she saw Grewe touching the younger girl "all over," the prosecutor said.

A 6-year-old neighbor boy also told a sheriff's interviewer that on one occasion at the man's home, Grewe offered him a lollipop and cocoa and asked if he could touch the boy's private areas.

The boy said he refused but Grewe touched him anyway, the prosecutor alleged.

The broader investigation began after "at least six members" of a fifth-grade class reported being sexually molested while on Grewe's school bus.

The Snohomish County Sheriff's Office is in the process of investigat-

ing the school bus incidents," Downes said in a court affidavit. "It does appear at this time, however, extremely likely that another multiple-count, multiple-victim case will soon be filed against the defendant."

Sheriff's spokesman Elliott Woodall lauded school officials today, saying they "acted immediately and responsibly as soon as they knew of a complaint." He said school officials contacted his department immediately after allegations were raised.

Downes said he will request that Grewe's bail not be lowered when Grewe appears today in court. It is expected to be at least two weeks before any additional charges are prepared, he said.

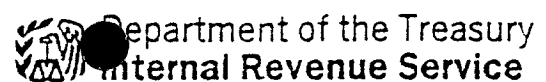

# 1987 Form W-4A



**What is Form W-4A?** This form is an easier way to figure your withholding than the 4-page 1987 Form W-4. If you have already given your employer a Form W-4 this year, do not file a new Form W-4A unless you wish to change your withholding.

**Caution:** Form W-4A may cause more or less tax to be withheld from your wages than you wish because it adjusts your withholding only for pay you receive after it takes effect. If not enough tax was withheld earlier in the year, you can increase your withholding by reducing the allowances claimed on line 4 of the form or by requesting that more money be withheld on line 5 of the form.

**Exemption From Withholding—Important Change in Law.** If you are a dependent of another person (for example,

a student who can still be claimed on your parents' return), you are not exempt if you have any nonwage income (such as interest on savings) and expect your total income to be more than \$500.

**What Do I Need To Do?** Exempt employees can skip the Worksheet and go directly to line 6 of Form W-4A. All others must complete lines A through G. Many employees can stop at line G of the Worksheet.

**Nonwage Income?** If you have a large amount of income from other sources (such as interest or dividends), you should consider either using the 1987 Form W-4 or making estimated tax payments using Form 1040-ES. Call 1-800-424-3676 (in Hawaii and Alaska, check your local telephone

directory) for copies of the 1987 Form W-4 and Publication 919, "Is My Withholding Correct?"

**When Should I File?** File as soon as possible to avoid underwithholding problems. If you do not file by October 1, 1987, your allowances may be adjusted to "1" if single or "2" if married and your take home pay may be reduced.

**Two-Earner Couples? More Than One Job?** To figure the number of allowances you may claim, combine allowances and wages from all jobs on one worksheet. File a Form W-4A with each employer, but do not claim the same allowances more than once. Your withholding will usually be more accurate if you claim all allowances on the highest paying job.

Dear Mr. Ernst:

Attached is the Confidential Record Sheet for Charles Grewe, along with the letter that we've given him suspending his membership in the Boy Scouts of America. Attached to the Confidential Record Sheet are the notes of the interview I had with Doug Shaw, Scoutmaster of Troop 49, who related the feelings of the parents that their [REDACTED], [REDACTED], had been sexually molested by Grewe while learning to swim.

The Council President and I met with Charles Grewe today and gave him the standard letter along with the information on how to appeal this decision if he chose to do so.

Lee Pintar explained very briefly to Mr. Grewe that some accusations by a parent had been made about him, possibly molesting their child at camp last summer and that we were now following the standard procedure outlined by the BSA. Charles said he understood the procedure and denied that he had done anything wrong to any boy, wanted to know the details, but we told him that we could not discuss details with him and the matter had been turned over to the Skagit County police. They would investigate the matter at this point and gather the facts from the parents and the boy as well as from Grewe to ascertain what had happened and whether the charges are substantiated.

Charles sat very quietly for a long period of time to gather his thoughts and said he probably would want to appeal this. We then told Charles how sorry we were to convey this to him because he had been a respected member of the Scouting community. This matter would be kept confidential and we would not share this with anyone including his employer. Charles finished by saying, "I guess there is really nothing to talk about" and left at that point.

This matter was turned over to the Skagit Police March 18 and by that afternoon they had made a contact with the parents. There have been subsequent calls to the Skagit Police Department and there have been no contacts with the parents. Next week they will assign an officer to investigate the charges.



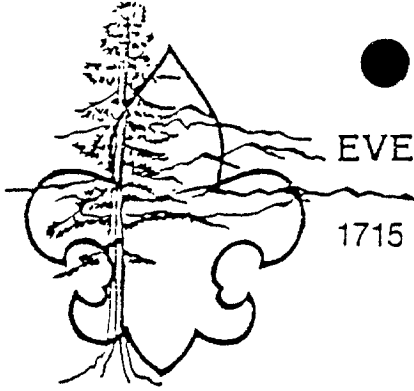

## INTERVIEW NOTES

Regarding: Charles Grewe

On March 18, 1988 at 10:15 a.m. I conducted an interview with Doug Shaw, Scoutmaster of Troop 49, [REDACTED], Alderwood Manor, WA 98036, [REDACTED]. Also present was Richard Szymanski, Puget Sound District Executive, who had been called on March 17.


Doug Shaw reported he had telephoned boys in his troop concerning signing up to go to camp with Troop 49. [REDACTED] said he did not want to go back this summer. When Doug Shaw asked why, [REDACTED] mother, [REDACTED] related that Charles Grewe fondled [REDACTED] while teaching him to swim (chest and private areas), all done in the water.

The boy asked Charles to stop after the first time. Charles apologized, but it happened after that once or twice more. Leaders from the troop, now reflecting back, while in camp felt the boy's emotional state changed and he stayed in his tent most of Thursday and Friday.

[REDACTED] became aware of the problem 2-3 days after camp. She wanted to do something then, but [REDACTED] Father, [REDACTED] did not and stopped any further investigation or reporting to any authority.

[REDACTED] has a learning disability and is shy.

The only people who know on the troop committee are the Committee Chairman, Scouting Coordinator and the Assistant Scoutmaster.
