Upon entering his home, Jim Meskan handed Charles the letter and Dave Walker asked him to please read this letter.




Dear Charles:

After careful review, we have decided that your registration with the Boy Scouts of America should be suspended. We are therefore compelled to request that you sever any relations that you may have with the Boy Scouts of America.

You should understand that BSA leadership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to suspend registration whenever there is a concern that an individual may not measure up to the high standards of leadership which the BSA seeks to provide for American youth. Please also understand that this decision and the reasons for it will be maintained as confidential.

If you wish to have this decision reviewed, please write to me, explaining your version of the facts supporting your claim that your registration as a BSA leader should be granted or reinstated.

Mr. [REDACTED] called me over and asked me if either [REDACTED] or [REDACTED] had spoken to me about an incident involving Charles Vaughn. I replied in the negative.

Mr. [REDACTED] then proceeded to tell me about the conversation he had overheard between [REDACTED] [REDACTED] had said to [REDACTED] that he just couldn't believe it that Charlie Vaughn had grabbed him by the balls. [REDACTED] replied, I know and I saw it happen.

After a short conversation with [REDACTED] I called both [REDACTED] and the three of us walked a little distance from the camp site. I then asked [REDACTED] if Charles Vaughn had grabbed him by the testicles at the camp fire the previous evening. [REDACTED] replied, yes and then started to hesitate, restated that he wasn't sure, that it may have been an accident. [REDACTED] then protested and stated that he had seen Charles Vaughn ~~to the~~ grab [REDACTED] where he should not.

Approximately 30 min. later I reported this matter to Tom Powell (Scout Executive) approx 8⁴⁵ PM Troop 421 because of rain left camp the evening of 11-24-84
cont.

Note; whatever occurred between Charles Vaughn had taken place just prior to the district camp fire on 11-23-84 @ perhaps 6³⁰ pm.

On Mon. morning 11-26-84 I called George Estiger to inform him of what had taken place. George has been with the troop longer than most of us and also serves on Council.

On Mon. ¹¹⁻²⁶⁻⁸⁴ evening I called [redacted] father and I asked him if [redacted] (brother) had said anything to him about an incident happening on this outing. I got the two brother's names mixed up so [redacted] still did not know about this incident. This however was corrected on Tue. 11-27-84 and [redacted] attended a special committee meeting which was held to

1. Try to determine what had taken place.
2. What the Troop Committee wanted to do about it if anything.
3. What we could do within Council to preclude any further incidents by ~~the~~ ^{RT} Charles Vaughn, if indeed we could determine that he had done so.

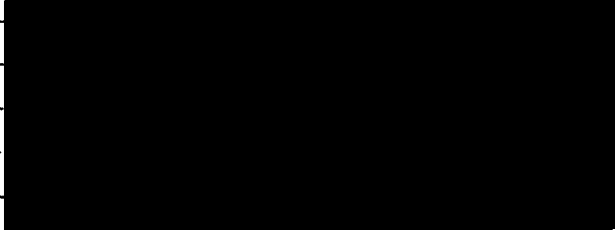
I was cooking breakfast on the
morning of Sat Nov 24th & heard

[redacted] and [redacted] talking
[redacted]; "I can't believe he did it."

[redacted] dropped my balls.
[redacted] "Well he did and I saw him"

I questioned them briefly and
ascertained that had happened just
before camp fire the night before.

I reported this to Scoutmaster
Russ Thompson, the next time I
saw him. (Within 15-20 minutes)



Dear Committee of troop 421

The incident happened on the night of the campfire before it started. I take med at that time so my alarm watch went off so I know what close to what time it happened, which was between 7:15 & 7:30 that night.

Everybody was excited and joking and kidding around. We were talking [redacted] and myself, and he tripped over my feet somehow. Charles Vaughn almost seemed to catch him. But he had fallen and gotten up already. When Charles arrived, he approached [redacted] and stood behind him for a moment or two then put his hand or fist between [redacted] legs very deeply.

I took Charles aside and said, "Charles, we have to set an example, why did you grab him there." his reply was, "It was not grabbing but punching".

Neither me or [REDACTED] said anything to my knowledge. Until morning the next day. We talked at the table and mister [REDACTED] over heard what we said so I told him the story and it was not long after that, that I heard from Mr. [REDACTED]. Bring the fact to my attention that we might have a problem on our hands. After that the subject was discussed a little but mostly dropped by me in [REDACTED] any way.
