Here is the letter you requested as per our conversation 3 weeks ago. In March or April 1987 one of my scouts, [REDACTED], and his mother and stepfather, approached me prior to the troop meeting and made an allegation of sexual misconduct against Clay Baker. Mr. Baker was one of my ASM's at the time.

During the conference with the boy and his parents, it was agreed to the satisfaction of all concerned, that Mr. Baker completely disassociate himself from Troop 320 and all scouting functions.

Recent inquiries to me from the Local Juvenile Authorities have brought to light that there were several youngsters in the troop that had been approached by Mr. Baker and touched or fondled on several occasions.

If you need any further information, please contact me and I will get it to you.
