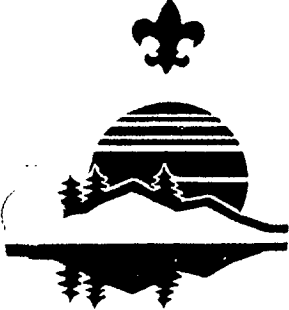

IT IS ADJUDGED that the defendant on 12/10/84 was convicted as found guilty, and is sentenced to the Wisconsin State Prisons for an indeterminate term of not more than 5 years with credit for time served.
