Cliff Kunde, a former merit badge counselor and rifle arms instructor for the Boy Scouts here, has been placed on probation for one year after he pleaded guilty to the fourth degree sexual assault of a 13 year old scout Nov. 5.

Kunde, 54, of 7827 W. Grantosa Blvd., was found guilty of assaulting the boy at a shooting range the scouts had in a basement at 409 W. Ring St.
