Wolf, 1453 Alger St., was treated at Memorial Hospital, Fremont, for a broken left wrist, police reports show. Wolf told police the players started having words, and one pushed him down.

Clifford Allen Stull, 35, 520½ May St., will be sentenced April 10 on the charge, which specifies physical harm to the victim.

Stull was originally charged with felonious sexual penetration of a 10-year-old girl and gross sexual imposition against a 9-year-old girl, court records show.

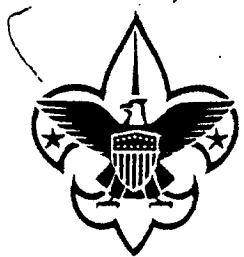

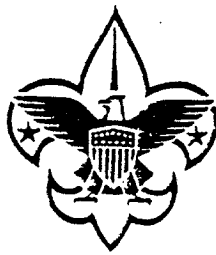
