



After careful review, we have decided that your registration with the Boy Scouts of America should be denied. We are therefore compelled to request that you sever any relations that you may have with the Boy Scouts of America.

You should understand that BSA membership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to refuse registration whenever there is a concern that an individual may not meet the high standards of membership which the BSA seeks to provide for American youth.

If you wish to have this decision reviewed by a BSA regional review committee, please write the Regional Director within 60 days of the date of this letter, explaining your version of the facts supporting your claim that your registration as a BSA member should be reinstated. The procedures for a review of this decision are attached.

2. Upon receipt of your written request, a committee will be appointed to review the situation.

3. You may attend the review hearing, but it is not adversarial in nature and neither the committee nor you will be represented by legal counsel. If you wish, you may be accompanied by no more than two individuals if their testimony might assist the committee in discovering the truth and arriving at a correct decision.
4. The committee will review the facts as presented, and may interview any persons whose testimony might assist them in arriving at a correct decision.
5. You will receive a letter setting forth the decision of the committee.
6. If you disagree with the decision of the committee, you may request a review of this decision by the National Council of the Boy Scouts of America.

Two shot; police search for man

Police are searching for the man they believe shot Juan Hurtado after an argument broke out while Hurtado was drinking with four friends.

When police were called to 434 S. Bates shortly before 1 a.m. Sunday, they found Hurtado lying in front of Apt. 1.

Witnesses told officers that Hurtado had asked a man to leave after they argued. A short time later, Hurtado walked into the yard. The other men heard a shot and saw Hurtado fall.

Police Chief Vance Chisum said Hurtado had been shot in the face with a shotgun. He was taken to Uvalde Memorial Hospital.

Oscar Trevino, 709 S. Camp, told officers he was walking down South Camp Street Saturday night when a car pulled up beside him.

A man leaned out the window, called Trevino a name and then shot him in the nose with either a BB or pellet gun.

Patricio Molina, 465 N. Crisp, was arrested at the intersection of Oak and First streets Monday and charged with making alcohol available to a minor.

The juveniles in the car with Molina were charged with minor in possession.

Clifford R. Bendler III, 108 W. Leona, was arrested at the Uvalde CISD bus barn Tuesday on a warrant out of Salisbury, Md. An employment check run by school employees revealed the warrant, according to Uvalde CISD transportation director Ed Hall. The warrant charges Bendler with a homosexual act with a boy.

Robert Allen Hudson, HC 2, Box 1243, Utopia, reported the theft of two packages of frozen pork and a Smith and Wesson .44-caliber revolver.

The theft, which was reported Aug. 22, is being investigated by the Uvalde County Sheriff's Department.
