Student Held In Molest

Prisoner's Car After Clairemont

A junior college student booked in city jail on charge and child molesting.

Detective Sgt. John M. Hughes identified by a boy, 16, who called last night. Hughes said he had molested five boys since Sept. 4.

Police identified the student as Clifford H. Anglin, 21, who lives in an apartment at 3738 31st St.

Hughes credited Sgt. William Guette and patrolman T. J. Bowling of the Northern Division for the arrest.

Boy Tells Experience

Bowling stopped a Clairemont boy at 10:45 p.m. for a routine interrogation regarding curfew," Hughes said.

The boy told Bowling he had been on his way to Clairemont Bowl when he had been offered a ride about 7 p.m. by a young man at Clairemont and Balboa Drives.

During the ride the driver pretended that the gas pedal was stuck, stopped the car and asked the boy to fix it. While the boy was working on the gas pedal the man held a knife against his neck. The boy grabbed it and broke the blade, which he threw out the window.

The boy then escaped through the car window and wrote down the license number of the car before it was driven away.

Earlier Cases Recalled

Bowling and Guette recalled that the method of operation was similar to that followed in the molesting of five boys previously.

The car was traced to Anglin's address.

The officers quoted Anglin as saying, "I went to the Clairemont area because I'm too well known in the east end. It was easier to pick up hitchhikers there."

Hughes said all the boys who were molested were picked up in the Clairemont area.
