On Tuesday, November 3, 1987, I received a call at home from Richard Howard, Division Supervisor for State's Attorney Ray Gill, informing me that he had received information from one of his attorneys, Julian Harrison, about a possible criminal record of sex offenses for the new Cubmaster in Bushnell, Clifton Tusing. He said they would be checking it out and would let me and the Scouting Coordinator, Thomas Moffitt, know what he found.

On Wednesday morning, November 4, I told Tom Deimler about the situation. Soon afterward I received a call at the Service Center from Tom Moffitt saying he had talked to Mr. Harrison and Sheriff Jamie Adams and that the record was confirmed. I got Tom Deimler on the phone and we discussed the situation and made arrangements to meet with Mr. Tusing on Thursday, November 5 to deliver the letter.

On Thursday, November 5, at about 6:45 p.m. I met with Tom Moffitt and Julian Harrison who gave me a copy of the FOLE and county records pertaining to Mr. Tusing. At about 6:50, Mr. Tusing arrived and met with Mr. Moffitt and me. Mr. Moffitt told Mr. Tusing he was asking him to step down and I gave him the letter from Tom Deimler. While Mr. Tusing was reading the letter Tom Moffitt asked Mr. Tusing to turn in a uniform the pack had purchased for him and any books he had gotten from the pack. Mr. Tusing said he would and that he was sorry. He then left.

Dear Mr. Tusing:

After careful review, we have decided that your registration with the Boy Scouts of America should be suspended. We are therefore compelled to request that you sever any relations you may have with the Boy Scouts of America. A \$5 refund of your registration fee is enclosed.

You should understand that BSA membership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to suspend registration whenever there is a concern that an individual may not measure up to the high standards of membership the BSA seeks to provide for American youth.

If you wish to have this decision reviewed, please write to me within 60 days of the date of this letter, explaining your version of the facts supporting your claim that your registration as a BSA member should be granted or reinstated. The procedures for review are attached.

APPLICANT PROCEDURE FOR REQUESTING REVIEW
OF DECISION DENYING REGISTRATION

1. If registration is refused, the applicant may request a review of this decision. This request must be in the form of a written request from the individual which includes his or her version of the facts supporting the claim that registration should not have been denied.
2. Upon receipt of the written request for review, the president of the local council shall appoint a committee to review the situation.
3. The appointed committee should review the facts as presented, and, in addition, may interview any persons whose testimony might assist the committee in discovering the truth and arriving at a correct decision.
4. A confidential report will be given to the applicant setting forth the decision of the committee.
5. The applicant may-if he or she does not agree with the decision-request a review from the regional director by submitting a written request for such a review within 30 days of the receipt of the local council decision.
6. If the regional review does not satisfy the applicant, he or she may ask for further review by the National Council by submitting a written request for such a review within 30 days of the receipt of the regional decision. The decision by the National Council is final.

Mark Griffin received phone call from Tom Moffitt, Scouting Coordinator/Pack 996, chartered by Church of God Universal, to discuss matter and then transferred call to T.R.D.

Apparently Mr. Clifton R. Tusing has been identified by a parent in the pack as having a prior criminal record for child molestation.
