Mr. Dale Lyle Logan, Cubmaster of Pack 70 in Artesia resigned from the Artesia school system for the reason mentioned in the letter. Upon inquiry I discovered that charges of moral perversion were dropped in Amerillo when Mr. Logan agreed to submit to psychiatric treatment. This was in 1963.
