Dear Howard:

The enclosed letter was received in my office the other day. I investigated the situation and this is what I discovered. Mr. Dale Lyle Logan, Cubmaster of Pack 70 in Artesia resigned from the Artesia school system for the reason mentioned in the letter. Upon inquiry I discovered that charges of moral perversion were dropped in Amarillo when Mr. Logan agreed to submit to psychiatric treatment. This was in 1963. In the Fall of 1963 he came to the Artesia school system with this information not forwarded from Amarillo. Several days ago notes were intercepted being passed to grade school boys of highly questionable nature. Mr. Logan was called in and readily tendered his resignation.

I have been told that his teaching certificate will be withdrawn from the state of New Mexico and undoubtedly it has already been done in the state of Texas.

Mr. Logan is 33 years old - married and has two boys - age ten and four. He is 6 feet tall, black hair, 180 pounds and immaculate in his dress. He holds a bachelor and master degree from West Texas State College at Canyon.

Please remove Mr. Logan's name from the list of registered Scouters in the Conquistador Council.
