

#### STATEMENT

A mother called and said that Mr. Trombley had been coashing her 10-year-old son on Tenderfoot requirements for Boy Scouts. He had asked to take the boy over to his apartment so that there would be less interference from other children in the boy's home. The mother was concerned. She was advised not to allow the boy to engage in this activity. Trombley was greeted by the boy's father that evening and run off the property after some harsh conversation.

Trombley transferred his Scout activity to another community and got involved in a similar situation in that community also. Inquiries by this office revealed a history of suspictous activity by his former employer and employees and minister of his church.

Trombley was invited in for conference and admitted homosexual activity and that his doctor had advised him to stay away from young boys that he was a "potential electric chair" case. Roy Henderson was invited into the conference for verification. This man admitted that he had been but he is now cured of homosexual tendencies. He continued to admit, however, that he could not keep himself out of difficult situations with boys and their parents that at anytime he would break. Both Mr. Henderson and I advised him to resign all positions in Scouting. He tendered his resignation as Scoutmaster and moved to Sarasota, Florida.






