The information on the confidential record sheet was obtained through the Nezperce county jail. Mr. Deyarmin is now serving his sentence. He is not currently registered with the B.S.A. and I do not believe he will try to register in this area. However, for the long term safety of our youth I do recommend that his name be placed on the confidential file.

It is sad to note that his arrest, admission and sentencing along with a pending embezzlement cas against a Den Leader from the same Pack has caused us to loose one of our largest Cub Scout Packs. You might also note that Mr. Deyarmin lewd conduct had nothing to do with the Cub Pack or the Boy Scouts of America.
