If you wish to have this decision reviewed by a council review committee, please write to me within 60 days of the date of this letter, explaining your version of the facts supporting your claim that your registration as a BSA member should be reinstated. The procedures for a review of this decision are attached.

[REDACTED] SAID THAT DANIEL MOORE WAS PUTTING HIS HAND INSIDE HIS SLEEPING BAG
PARENT CALL TONY CORVIELLO AND ASK HIM TO INSURE PROPER ACTION ABOUT
THIS PROBLEM, PARENT WAS VERY UPSET. IT SEEMS THIS INCIDENT OCCURRED BEFORE
WITH THE SAME BOY [REDACTED]

[REDACTED] DURING A NATIONAL EVENT (JANUARY?)
BUT THIS WAS THE FIRST TIME THAT THE BOY BROUGHT IT UP. TONY CORVIELLO ASK ALL
BOYS IN TROOP ABOUT ANY OTHER INCIDENTS, ANOTHER BOY [REDACTED] SAID THAT
SOMETHING LIKE HAD HAPPENED TO HIM OVER A YEAR AGO AT T.V. (HAND INSIDE THE BAG)

PARENTS WILL NOT TAKE LEGAL ACTION FOR SUDE, BUT WANT TO BE CERTAIN THAT
THIS WON'T HAPPEN. TROOP COMMITTEE MET AND DANIEL MOORE WAS INVITED,
HE DID NOT DENIED IT, (IT COULD HAPPEN) WHEN ASK IF HE WAS A HOMOSEXUAL HE SAID
HE DIDN'T KNOW, HE DIDN'T ^{THINK} HE WAS. HE SAID HE WOULD GO FOR HELP MAYBE
TO SEE HIS CLERGY OR A PSYCHIATRIST, THIS WAS ALSO RECOMMENDED BY THE COMMITTEE

THE COMMITTEE THEN ASK HIM TO RESIGN FROM SCOUT MASTER, HE AGREED TO THAT.
ANOTHER INCIDENT SEEM TO HAVE OCCURED OVER A YEAR AGO AT THE ISSAC JONIS TRAIL &
THAT, THE BOY HAD LEFT THE TROOP.
