Dear Mr. Purvis:

After careful review, we have decided that your registration with the Boy Scouts of America should be denied. We are therefore compelled to request that you sever any relations that you may have with the Boy Scouts of America. A refund of your registration fee is enclosed.

You should understand that BSA membership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to refuse registration whenever there is concern that an individual may not meet the high standards of membership which the BSA seeks.

If you wish to have this decision reviewed by a BSA regional review committee, please write to the regional director within 60 days of the date of this letter, explaining your version of the facts supporting your claim that your registration as a BSA member should be granted. The procedures for a review of this decision are attached.

STATEMENT

I, [REDACTED], have worked for J.C. Penney for 4 years in Security and on or about July 8, 1991, I was checking the men's restroom when I noticed two men engaged in a sexual act in the restroom. At the time I did not know his name, but recognized his face. I learned later that his name is Dan Purvis. Mr. Purvis is the person instigating the act on the other male person. This person has been observed for about 3 years in the Penny restroom.

Dick,

We received a call from Marvin Atkins on Friday, August 2, regarding an assistant Scoutmaster who is a known homosexual.

Briefly, two boys (Scouts) were being held at the Buchanan County Juvenile detention hall for unrelated charges (intimidation and/or extortion). When the father of one of the boys came to pick them up, a Juvenile Detention employee recognized him as the same man he had observed performing fellatio on four previous occasions in the East Hills Mall J.C. Penney's restroom. He did not previously know who the man was but, seeing him with the Scouts made him investigate.

The troop committee chairman is a Chieftain, the Scoutmaster is an employee of the St. Joseph Police Department.\*

Marvin has found out that neither the man nor his son are planning to attend the Mic-O-Say Pow Wow this weekend. He will call you early on Monday after your return. He will also verify the details of the J.C. Penney incidents with the Juvenile Hall employee (two adults/adult-youth/etc.) so that we have as much solid information as possible to proceed.

\*Marvin did not give the SA's name but I surmise he must be in Troop 36 (1st Presbyterian) as Jim Trout is the CC and Jon Kreiser (of the St. Joseph Police) is SM.
