I promised I would get back to you related to the above named individual. I have now received a note from David Park, our corporate attorney. He carefully reviewed all the file, except for the last letter which I just received from you.

Mr. Park has indicated that he does not wish for Mr. Dunnigan to be reinstated at this time. As I indicated to you in my previous letter, we normally do not reinstate people who are on probation, and I really feel that we need more information concerning this whole matter. This could best be accomplished through a review by a committee in your council, if Mr. Dunnigan wishes to pursue this situation.

You did indicate to me that the matter could have been dropped if it had been handled differently. I did not quite understand your statement. Perhaps this could all come out in a review and the minutes of a review committee.

Please let me know if we may be of further help to you. At the present time we would not register Mr. Dunnigan with the Boy Scouts of America.

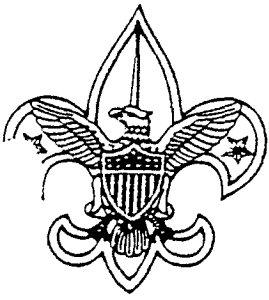

Thank you for your letter of March 6 regarding Daniel L. Dunnigan. I have received another letter testifying to Dan's character. Copy enclosed.


I have found out from one of the investigators on a confidential basis that had Dan not said anything at the time and asked for a lawyer, the whole matter would have been dropped.

The court also must have felt something had occurred or they would not have placed him on probation but simply dismissed the charges.

I am referring this to our corporate attorney for review. I will give you his decision as soon as I receive it.

Thanks for your help in this matter.

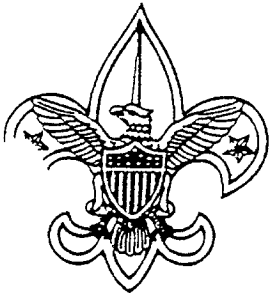

You have been granted an Adjourment in Contemplation of Dismissal this date which adjournment is for a period of 30 years 0 months. During the period of Adjourment in Contemplation of Dismissal you shall observe the following conditions:

GENERAL CONDITIONS:

1. Remain within the jurisdiction of the Court unless granted permission to leave by the Court and promptly notify the Court of any change in address or employment within 48 hours of any such change.

OTHER CONDITIONS:

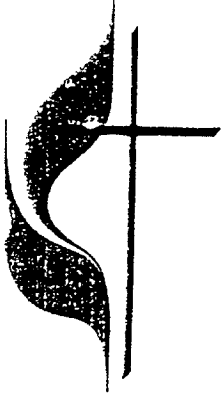
2. Avoid any violation of the law whatsoever.
3. That you shall refrain from association with probationers, parolees, or persons of disreputable or harmful character.
4. That you work faithfully at suitable employment, or, if attending school, do so regularly.
5. That you shall make restitution, as directed by the Court, of your proportionate share involved in this incident, if any.
6. That you shall refrain from all injurious or vicious habits, use of any non-prescription drugs, narcotics, marijuana, or overindulge in alcoholic beverages as directed by the Court.

7. That you shall be on good behavior during the term of this adjournment.
8. Contact Social Service for Counseling services in connection with original charge
This period of Adjourment in Contemplation of Dismissal shall expire on 9-6-89 unless terminated by the Court prior to the aforementioned date.

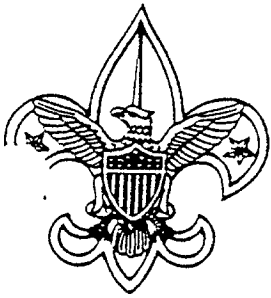

Please find enclosed the paper work in reference to the above named individual. Between 1 and 2 p.m. on Wednesday December 7, Scott Brady, District Executive; Hon. George S. Kepner Jr., Council President, and myself personally delivered the letter of separation to Mr. Dunnigan.

Mr. Dunnigan seemed to be very depressed and stated that he was thinking about calling us. He further stated that he was being accused of something he did not do. I explained to him that the letter separating him from the Boy Scouts of America and returning his fee was necessary because of alleged accusations against him, and he stated he understood. I indicated that I was sorry that this needed to be done and wished him luck, as in the past he has been a very, very dedicated volunteer.

I have been informed that Mr. Dunnigan's court appearance will be on the 12th. Hopefully, as this was an alleged act of an individual in a private home, and not in connection with a Scouting activity, this may not be picked up by newspapers, but if it is, I think I am prepared. I think it is well to note that the reason Mr. Dunnigan was in the Ballard home was to deliver a form needing the Pack Chairperson's signature to move their meeting place.

I have been in contact with Public Relations Division and have talked to Deborah Duhs Secretary and have authorized counseling for the daughter. The mother seemed to be pleased and was quite talkative and jovial as far as I was concerned.

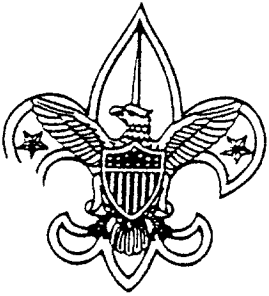


