Following up your letter of August 4, 1988 concerning the above individual, the outcome of the legal action has just been determined.

David Meadows was charged in December, 1987. On July 11, 1988 he plead guilty in San Joaquin County Superior Court to three felony child molestation charges with three separate boy victims. He was sentenced on August 1, 1988 to felony probation and is classified as a Section 290 Registrant, whereby he must register with local law enforcement authorities. This information was communicated to me by Council President Stephen Demetras, who states this information is a matter of public record.



If you wish to have this decision reviewed by a council review committee, please write to me, explaining your version of the facts supporting your claim that your registration as a BSA member should be reinstated.
