Dear Paul:

Enclosed are some notes on a Daniel Tolle. Recently Bill McCartin of the Aurora Police Department called me and said this man is in town where he works at a pet shop. He received a call from New York indicating that the man had been charged with fifty-six counts of sodomy, but the case was dropped because the victims were all mental patients and could not testify. Officer McCartin indicated he thought Daniel Tolle was a participating Scout leader in either a Pack or Troop 438. He also indicated the Scouts were spending overnights with him, but all the boys interviewed claimed nothing sexually occurred.

We checked with the leadership of Pack and Troop 438 and discovered that Daniel Tolle was not registered. However, it was discovered that Mr. Tolle has a son and a copy of his application is enclosed. You will notice Daniel Tolle indicates he has been an Assistant Scoutmaster, Scoutmaster, Webelos Den Leader, and an Eagle Scout; therefore, it occurred to us that he might try and register somewhere. Obviously with that kind of record, we would remove him immediately if he became affiliated with the Boy Scouts.

The leadership of Pack and Troop 438 are aware of the situation and will keep a close eye on him, but in the meantime I thought this information would be of value to our national registration service.
