Enclosed is confidential record sheet for Daniel W. VanLuven either of [Redacted] Copenhagen, N.Y. 13626 or of his Watertown address. The two addresses are because he is in a Special School because of retardation.

He attempted to register with Troop 15, Watertown, N.Y. in September of 1985 but rejected for one year because of rather suspicious actions with younger boys. (Please see copy of letter). In August of '86 he was arrested and pleaded guilty of sexual abuse of a 13 year old boy. (Copy of convictions and news clipping enclosed.) He had no affiliations with Scouting at this time nor had any in the previous 10 months.

I strongly recommend that Daniel W. VanLuven should never be allowed to affiliate with the Boy Scout Movement now or any time in the future.

City Man Arrested In Sex Abuse of Boy

A 21-year-old city man who allegedly sexually abused a 13-year-old boy, then followed him home, was arrested Thursday night by city police.

Daniel W. Van Luven, of [REDACTED], was scheduled to be arraigned Friday in city court on charges of sexual abuse, second degree, and unlawful imprisonment.

City police arrested the man after the boy told them Van Luven had made advances while he was at Van Luven's apartment. Van Luven allegedly then followed the child home.

After careful review, we have decided that your registration with the Boy Scouts of America cannot be considered at this time. We are therefore compelled to request that you sever any relations that you may have with the Boy Scouts of America.

You should understand that BSA leadership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to deny registration whenever there is a concern that an individual may not measure up to the high standards of leadership which the BSA seeks to provide for American youth. Please also understand that this decision and the reasons for it will be maintained as confidential.

If you wish to have this decision reviewed, please write to me, explaining your version of the facts supporting your claim that your registration as a BSA leader should be considered. Also, in the future, and we suggest not less than one year from this date, the Seaway Valley Council will review the possibility of your registration in the Boy Scouts of America. This review will only happen if you desire and make this request via written communication.
