The CM has been advised to report the incident to Family Services and we have contacted the [REDACTED] on December 5, 1989 and our Council Attorney. [REDACTED] December 5, 1989 briefing them of the accusation made by the CM and appropriate action being taken by the Council. A registered letter will be mailed to Mr. Potter severing his registration with the B.S.A. and refunding his registration fee.
