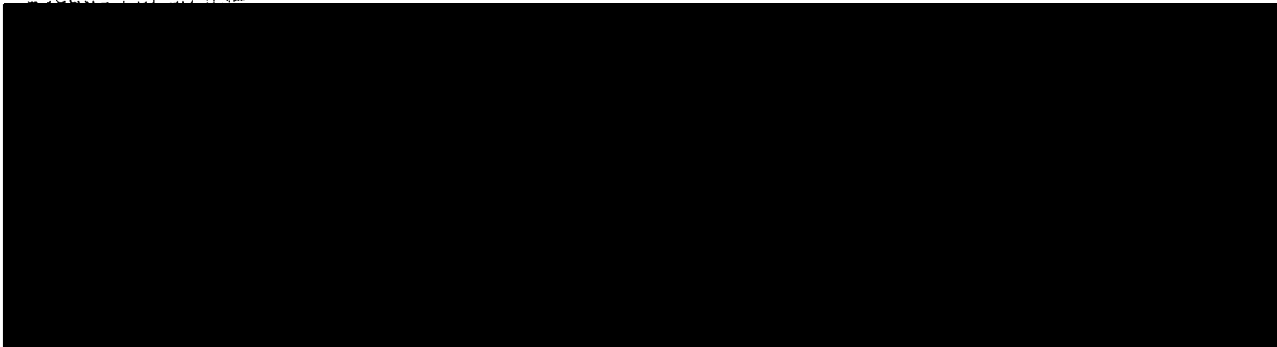

Thank you for your letter of September 18 concerning the above-named individual. This information is most helpful, but I do not know if this undocumented information would enable us to have a confidential file which would lead to refusal of registration attempts.

If Mr. Bibeau still lives in your council and you could complete a Confidential Record Sheet, I would certainly place him on the file in a "probationary" status, which would alert any council where Mr. Bibeau tried to register.

I believe the sexual abuse charges are very pertinent, but without having the names of individuals or the dates when anything happened, we are left with very weak information which would support our registration refusal.

The original telephone call came to our office in October of 1986 from Jim Batties.. Unfortunately, no further information came to us which would help to support, at that time, refusal of registration attempts.

Let me know if I may be of further help to you. I am enclosing a Confidential Record Sheet for your use if you feel that you can get the necessary information for completing this. Thank you for your help.

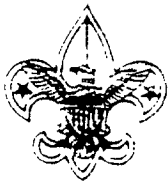

Dear Paul,

John Green has asked me to respond to you with information on a former volunteer in our council by the name of Dave Bibeau. I have already given the information I have uncovered over the phone to Claire Miller in your office. Let me recap for you what I have found out.

Mr. Dave Bibeau was formerly the Scoutmaster of both Troop 4 and Troop 15 here in the Great Southwest Council. Both troops currently are not in service and he currently holds no registration with our council.

Concerning possible reasons to have him on the BSA Confidential List, I have found two disturbing pieces of information. One, alleges that some parents a few years ago, complained that Mr. Bibeau had sexually abused their son. There is only one volunteer left that knows the background on this and refuses to discuss the matter further. I was not able to get the names of the parents.

Another item we have found is that Mr. Bibeau supposedly has an arrest record for having chained himself to a road sign in protest of a new road that was disturbing his business.

I have contacted both Andy Braman, Assistant Scout Executive, Lubbock, Texas and Jim Battles, Field Director, Alamo Area Council who were both former Field Directors of Great Southwest Council to provide you with the information I included in this letter.

John Green and I are both eager to have a satisfactory conclusion to this matter. We would be agreeable to filling out a Confidential File form if we do indeed have enough information to substantiate it.

If I can be of further assistance to you please let me know.

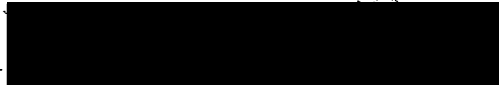
