Enclosed is a copy of my letter to David A. Krause, suspending him from registration with the Boy Scouts of America. Additional information is provided by copy of the Confidential Record Sheet.


Recently I received a phone call from Tom Cobert who is a freelance social worker, and had worked with Detective Mike Moreno on the case. It caused Mr. Krause's suspension due to sexual child abuse.

Mr. Cobert's phone call was to alert the Boy Scouts of America that David Krause is now living in New York and he believes may be working with the Scouts in that area under an alias. He is now David A. Kruszczyński (his family's original name) and his address there is: [REDACTED] Aurora, New York 14052. Mr. Cobert says that this person is a "chronic pedophile" and will never be cured, that he gets a kick out of the abuse, thinks it's a game. He is considered to be of "severe danger" to the Boy Scouts.

It was the intent that he and Detective Moreno would notify the appropriate New York authorities to make sure he is on the "Abuse Registry".

I wanted you to have this information for whatever followup you are able to do there and hopefully avoid a future problem.

Dear Mr. Krause:

After careful review, we have decided that your registration with the Boy Scouts of America should be suspended. We are therefore compelled to request that you sever any relations you may have with the Boy Scouts of America. A refund of your registration fee is enclosed.

You should understand that BSA membership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to suspend registration whenever there is a concern that an individual may not measure up to the high standards of membership the BSA seeks to provide for American youth.

If you wish to have this decision reviewed, please write to me within 60 days of the date of this letter, explaining your version of the facts supporting your claim that your registration as a BSA member should be granted or reinstated. The procedures for review are attached.

Investigation is proceeding on David Krause by Detective Mike Marino from a complaint by the parents of Scout ██████████ a member of Troop 50, chartered by Hillsborough United Methodist Church.

Investigation is concerning lewd & lascivious acts with a child under 16 years of age - Florida Statute 800.04.

Incident was to have taken place on May 13, 1988 at Menard Park, Hillsborough County.

Linda Jacobson has also reported discovering Mr. Krause with a boy, 13, inside his tent.

I met with Detective Michael G. Marino ██████████ and Dr. Philip F. Quinn on Thursday a.m. July 21, 1988 at which time Detective Marino was furnished a roster of boys and adults of Troop 50.

Detective Marino emphasized that this was an investigation and no charge had been filed. He also stated he would let us know if an arrest took place.

RE: David Krause resignation from Scouting

At 9:50 a.m. Rosemary Morley arrived to discuss the flow of the meeting with David Krause. At 10:06 David Krause arrived at the Scout Service Center. Rosemary Morley thanked David for coming and proceeded. Charles Herrera then presented a confidential envelope to David and asked him to review the enclosed materials. He accepted the materials and reviewed them.

After reviewing the material I told David that, on behalf of the Gulf Ridge Council, I am asking him to resign from Scouting. David responded by saying that H.R.S. had dropped the investigation because of a lack of evidence and that the troop has asked him to return. He said that the County Sheriff's office is waiting for Mr. Jacobsen, the Scoutmaster, to return from vacation to question Scout Mark Jacobsen to see if there is a need to press criminal charges. I advised David not to return to any Scouting meetings until such time he has submitted an appeal to the Gulf Ridge Council Executive Board and that such appeal has been accepted and membership has been reinstated.- David concurred and left the meeting at 10:25 a.m.

I also advised David that if he appeals the resignation he must have written documentation in support of the appeal and his reinstatement.
