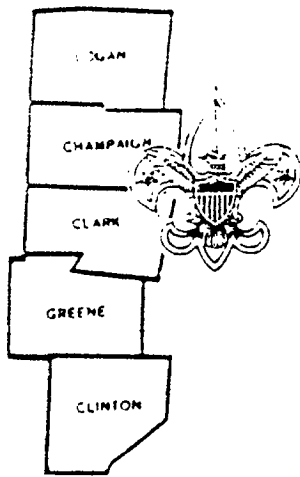


David A. Voorhees pled guilty on January 7, 1986 to two counts of Gross Sexual Imposition and one count of corrupting a minor.

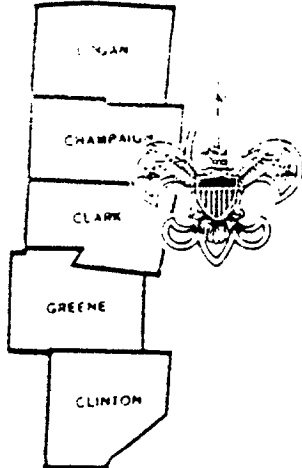



The facts:

Twenty year old Assistant Scoutmaster David Voorhees (an Eagle Scout) of Grace Methodist Church's Troop #25 has been charged with:

- 3 counts of rape
- 1 count of gross sexual imposition

Two of the victims are Boy Scouts in troop 25.

No media calls yet. The minister of Grace Methodist Church and George Stone are to meet with the parents of the two boys. The council president is aware.

ACTION OR RECOMMENDATIONS:

Stone was encouraged to:

- Inform Bob Birkemeier and Bob Durgin immediately
- Temporarily suspend Voorhees (in unison with Grace Methodist)
- Not release names of boys
- Act as sole spokesman when the media calls
- Say only that Voorhees has been suspended from BSA activity and that BSA has more than 1 million volunteers who do live by the Scout Oath and Scout Law.
