

STATEMENT

February 14, 1973

At 5:30 p. m. on Tuesday, February 13, 1973, I was requested by Calvin E. Wheelock, Scout Executive, Golden Empire Council, Boy Scouts of America, to make an appointment with and gain interview with Mr. or Mrs. [REDACTED] of [REDACTED], concerning an alleged incident of homosexual molestation in which an adult Scouting volunteer, Mr. David Pease was allegedly involved.

At 7:45 p. m. the same day, having obtained an appointment, I interviewed [REDACTED] and [REDACTED], the two boys involved in the incident. The interview was conducted in the [REDACTED] home with the [REDACTED] parents in attendance and with verbal approval of Mrs. [REDACTED]. Both boys were interviewed independently with Mrs. [REDACTED] in attendance at all times during each interview. Their combined statement is attached.

STATEMENT

"On Friday, February 9, 1973 David Pease, District Commissioner of Golden Spike District, Golden Empire Council, Boy Scouts of America visited a meeting of Troop 255. At that time, he asked [redacted] Senior Patrol Leader, age 14 of [redacted] Sacramento if he would be interested in helping him visit other troops in the District to help promote Order of the Arrow elections and activities. [redacted] with his parents' permission, agreed. Monday, February 12, Pease called [redacted] and arranged to visit Troop 8 that evening. [redacted] asked if his Assistant Senior Patrol Leader, [redacted] of [redacted] Sacramento, could go along. Pease agreed and he picked up both boys at the [redacted] residence at about 6:30 p.m.

After they departed, Pease stated that they were too early to go to the meeting and invited the boys to his apartment, located at 15th and O Streets, Sacramento. Once there, he offered both boys a can of beer and engaged them in conversation about Scouting. He tried to influence them not to go to the Troop meeting, but was unsuccessful in doing so. The trio arrived at the Troop meeting at about 7:45 p.m. and stayed for about twenty minutes. At this point Pease suggested that they return to his apartment to further discuss Scouting. As soon as they had arrived he poured both boys a glass of whiskey and water and excused himself to retire to his bedroom to change clothes. At this time, both boys poured out their drinks before he returned. Upon returning, Pease was dressed in what the boys describe as 'extremely tight hip-hugger trousers'. He played several stereo tapes for them and engaged in small talk. [redacted] became uneasy and insisted that he had to be home by 9:00 p.m. and Pease obliged by driving both boys to the [redacted] residence. [redacted] got out of the car only after questioning by Pease concerning when they could meet again. At this point, Pease persuaded the [redacted] boy to return to his apartment once more. Once there, he started the Scouting conversation again. After a short period of time watching television, Pease's conversation suddenly turned to sexual stories and experiences of his own youth involving homosexual acts. He displayed several pictures showing males in the act of homosexual relationships and sex acts and asked [redacted] if he liked them. The boy was non-committal. He then asked [redacted] if he would like to try it (oral copulation). [redacted] declined and stated that he had to get home - it was getting late. Pease said that he couldn't find his keys and asked [redacted] to help. While searching, Pease moved to a position back of the boy and when [redacted] turned around, Pease grabbed him and attempted to remove his trousers. Failing in that, he attempted to bite and suck the genital area of the boy's trousers, asking if he [redacted] liked it. The boy withdrew and insisted that he be taken home immediately. Pease obliged, advising [redacted] not to 'tell on him' many times during the ride to the [redacted] home ([redacted] car was there). Pease also asked [redacted] many times for a date when he could see him again.

On Tuesday, February 13, 1973 Pease called the [redacted] home and talked to [redacted] to make certain that neither boy 'would get into trouble because they were out so late'."
