NOW COMES the State of New Hampshire by Jacqueline L. Sullivan, Assistant County Attorney for the County of Cheshire, and pro se, to inform this Honorable Court that David C. Demers of West Swanton, N.H., between February 15, 1986 and March 16, 1986 at West Swanton, N.H., in said County and State, did commit the offense of Sexual Assault, contrary to RSA 632-A:4 and the laws of the State of New Hampshire for which the Defendant should be held to answer in this Court. The Defendant did knowingly engage in sexual contact, to wit: placing of the said Demers' hands on the breasts and vulva of another person, not his legally married spouse, to wit: one [redacted] against the peace and dignity of the State.

WHEREFORE, the State prays that the Defendant be held to answer to this charge and that Justice be done.
